Call to Order

Council President Kristen Nye called the meeting to order at 6:03 p.m. and presided.

Chamber Security and Spanish Interpretation Announcements

Security policies and expected conduct for members of the public present in the Council Chamber were announced.

City Clerk Candice Reid stated that Spanish interpretation service was available in the Council Chamber and that attendees should speak with a representative to receive the appropriate equipment. City Clerk Reid also stated that Spanish interpretation service was available virtually through Microsoft Teams.

Roxana Talavera-Denson, Language Access Coordinator, Office of Immigrant and Refugee Engagement, then provided Spanish interpretation of previously provided announcements.

Pastor Vernon Gordon of The Life Church RVA, 5515 Bryce Lane, Richmond, Virginia, provided the invocation.

Members of Council and the audience recited the Pledge of Allegiance.

Public Comment

Amy Scharf addressed Council and stated her concerns regarding the events of October 7, 2023, in Israel. Ms. Scharf requested that Council commit to taking action to improve the lives of city residents.

Tara Morand addressed Council and requested that members adopt a proposed ceasefire resolution related to the conflict in Gaza. Ms. Morand also requested that Council improve city services.

Jamie Weinstein addressed Council and stated her appreciation for recent city infrastructure improvements. Ms. Weinstein also stated that she did not believe a Gaza related ceasefire resolution should be a concern for Council.

Anna Mackiewicz addressed Council and stated her concerns about unhoused individuals in the city. Ms. Mackiewicz also stated that the city and local businesses should do more to help individuals impacted by a housing crisis in the city.

Kathy Brown addressed Council and stated her concerns about the Department of Public Utilities (DPU) estimating her water bill. Ms. Brown also stated that she believed the estimates were incorrect, and she requested that DPU be audited.

President Kristen Nye informed Ms. Brown that city staff was available in the Chamber to address her concern.

Christine Peterson, Richmond Public Library Board Chair, addressed Council and informed members of recent Richmond Public Library Board accomplishments. Ms. Peterson also provided a handout that detailed library services available to the public.

Public Hearing

Robert Cordova spoke in opposition of ORD. 2024-205, and stated his concerns about the impact of the proposed stop signs. Mr. Cordova also stated that the city should not rely on all-way stop signs to calm traffic.

Martin Wegbreit, Central Virginia Legal Aid Society emeritus pro bono attorney, spoke in support of RES. 2024-R027, and stated that the right-to-counsel would help city residents remain housed and avoid unnecessary evictions.

Dale Reed, Central Virginia Legal Aid Society Housing Attorney, spoke in support of RES. 2024-R027, and informed Council of her experience as legal counsel involved with eviction proceedings in the city. Ms. Reed provided examples of unlawful evictions that were prevented due to a resident having the assistance of legal counsel.

David Tisel, Hunton Andrews Kurth pro bono fellow, spoke in support of RES. 2024-R027, and stated legal representation can help prevent unnecessary evictions. Mr. Tisel also stated that the proposed resolution would help increase the Central Virginia Legal Aid Society's resources to assist residents in need of legal representation.

Courtney Farrar, RVA Rapid Transit Ambassador, spoke in support of ORD. 2024-216, and stated that the proposed North South Bus Rapid Transit (BRT) route will increase ridership and provide needed transportation. Ms. Farrar also spoke in support of RES. 2024-R027.

Bridgette Whitaker spoke in support of RES. 2024-R027, and she also stated that the city needed to ensure it has the ability to provide needed resources related to RES. 2024-R029 regarding the designation of the city as an Inclusive Recovery City.

Claire Moore, Virginia Commonwealth University (VCU) Health registered nurse, spoke in support of RES. 2024-R027, and informed Council of her experience providing health care to unhoused residents. Ms. Moore also stated her concerns about the difficulty unhoused residents have with obtaining sufficient health care.

Kathleen Kramer, Enterprise Community Development representative, spoke in support of ORD. 2024-233, expressed her appreciation to Council, and stated that the proposed development would help increase the amount of affordable housing options in the city.

Councilor Andreas Addison stated his appreciation for members of the public and Council that supported RES. 2024-R027. Councilor Addison also stated the right-to-counsel will help residents stay housed and help facilitate amicable solutions between residents and landlords regarding overdue rent.

Councilor Stephanie Lynch stated her support for RES. 2024-R027, and requested that the city do more to lower the amount of evictions in the city.

Councilor Nicole Jones stated her support for RES. 2024-R027, and stated that the resolution should lead to more discussions regarding how the city can address housing instability. Councilor Jones also stated that the city needed to examine how to increase funding for right-to-counsel in the next fiscal year budget.

Councilor Ellen Robertson stated her support for RES. 2024-R027, and she also stated the city needed to address affordable housing and poverty in the city.

Councilor Cynthia Newbille stated her support for RES. 2024-R027, and she also stated that the city needed to improve its strategy to address housing instability.

Vice President Ann-Frances Lambert stated her support for RES. 2024-R027, and she also stated that Council and residents need to lobby the General Assembly of Virginia to provide the city more options to address housing instability. Vice President Ann-Frances Lambert requested to be added as a co-patron of ORD. 2024-222.

There were no further comments or discussions and the Consent Agenda was unanimously adopted.

To authorize the Chief Administrative Officer, for and on behalf of the City of Richmond, to execute a Grant Agreement between the City of Richmond, the Elmington Capital Group, LLC, and the Economic Development Authority of the City of Richmond for the purpose of facilitating the construction of an affordable residential development located at 2201 McDonough Street, 2301 McDonough Street, 2300 Semmes Avenue, 2310 Semmes Avenue, 2310A Semmes Avenue, 211 West 22nd Street, 215 West 22nd Street, 217 West 22nd Street, 219 West 22nd Street, 221 West 22nd Street, 301 West 22nd Street, 302 West 22nd Street, 307 West 22nd Street, 315 West 22nd Street, 322 West 22nd Street, 222 West 21st Street, and 2100 Perry Street.
(5th District)

Patrons: Mayor Stoney

This ordinance was adopted.

Kevin Vonck, Director of Planning and Development Review, provided an introduction and additional background information regarding the proposed ordinances.

T. Preston Lloyd, Jr., attorney representing the special use permit applicant, provided additional background information regarding the proposed development, and he addressed certain decisions made regarding construction and infrastructure improvements.

A copy of the material provided has been filed.

Public Hearing

Vaughn Garland spoke in opposition and stated his concerns about the development's potential impact on his neighborhood. Mr. Garland informed Council that he supported affordable housing development, but he noted his belief the development did not have sufficient infrastructure around it to succeed.

Pippa Holloway spoke in opposition and stated that the development did not have sufficient infrastructure to handle the amount of proposed housing units. Pippa Holloway also stated concerns about the development not having access to Semmes Avenue.

Crista Fore spoke in opposition and stated her concerns that the surrounding neighborhood could not handle the amount of units planned for the development.

Thomas Alleman spoke in opposition and stated the site of the proposed development was a flood plain better used for industrial activity rather than residential. Mr. Alleman also stated the surrounding area would not be able to handle the increased traffic due to the amount of units and lack of needed infrastructure.

Will Wilson, RVA YIMBY member, spoke in support and stated that the city needed more housing units to satisfy housing demand. Mr. Wilson also stated that affordable housing developers would be discouraged from development if Council rejected the development's requested special use permit.

Joseph Carlisle spoke in support and stated that the proposed apartment development would be a good use of available land.

Casey Flores spoke in support and stated that he believed the development proposal included enough infrastructure improvements to address the need.

Grayson McKinley spoke in support and stated the proposed development would provide needed housing for families.

Warren Campbell, New Virginia Majority community organizer, spoke in support and stated his concerns about rent burdened residents in the city. Mr. Campbell also stated that he supported the proposed development, but noted that he did not believe the development provided true affordable housing.

Matt Jones spoke in support and stated that the development would provide much needed housing. Mr. Jones also stated his support for the development due to its proximity to Semmes Avenue.

Reverend Cheryl Johnson spoke in support and stated the development would improve the quality of life of residents and surrounding neighbors.

Councilor Andreas Addison addressed the legislative history of the proposed ordinances. Councilor Addison noted his concerns about the buildings' lack of access to Semmes Avenue and requested more information about possible action to be taken by the city and developer to increase access.

Councilor Nicole Jones requested more information regarding the development's lack of access to Semmes Avenue. Councilor Jones also inquired why the development would provide rental rates at 60% area median income (AMI) and not 30%. Councilor Jones further inquired about the city's commitment to improve surrounding infrastructure.

T. Preston Lloyd, Jr., attorney representing the special use permit applicant, provided Council with information regarding the developer's decision not to address access to Semmes Avenue. Mr. Lloyd stated that the development had to make certain financial decisions to ensure the cost of construction remained low enough to provide affordable housing units. Mr. Lloyd also stated that development financing could not cover the cost of providing rental units at 30% AMI, and he noted that vouchers to help supplement rental costs should be used for future housing developments to ensure rental opportunities at 30% AMI.

Chief Administrative Officer (CAO) Lincoln Saunders, and Merrick Malone, Acting Director of Housing and Community Development, provided Council with information regarding planned infrastructure improvements, and what the city was planning to address affordable housing developments that would provide rental rates at 30% AMI. CAO Saunders also stated that an awarded performance grant, as well as a future development agreement between the city and developer, would ensure that discussed infrastructure improvements are made.

Councilor Ellen Robertson stated that she supported the development because it provided much needed housing rates at 60% AMI, but she noted her desire to work with city administration, Council, and developers to address the need for housing developments that provided rental rates below 60% AMI. Councilor Robertson also stated that she hoped future changes to the city's zoning ordinance would make it easier for affordable housing developments to be established without the need for special use permits. Councilor Robertson requested that methods to increase Semmes Avenue accessibility be reviewed during the drafting of a future development agreement. Councilor Robertson informed members she supported the special use permit.

Councilor Cynthia Newbille confirmed from Mr. Lloyd that the developer and city would be addressing certain infrastructure concerns raised by the surrounding community, and that the improvements would be addressed in the future development agreement. Councilor Newbille informed members that she supported the special use permit, so long as the agreed improvements would be included in the future development agreement.

Councilor Reva Trammell stated that she supported the proposed development.

Councilor Stephanie Lynch stated she appreciated the developer's intent to make certain infrastructure improvements requested by the community. Councilor Lynch informed members that she would not vote to adopt the ordinances because the development agreement ensuring the completion of the referenced infrastructure improvements was not yet submitted or approved by Council.

President Kristen Nye stated her appreciation to residents that provided comment, and she noted her belief that the city benefited from the in depth conversation regarding the requested infrastructure improvements.

There were no further comments or discussions and ORD. 2024-180 and ORD. 2024-207 were adopted: Ayes 8, Addison, Jordan, Jones, Robertson, Trammell, Newbille, Lambert, Nye. Noes 1, Lynch.
