### Call to Order

Chair Reva Trammell called the meeting to order at 1:05 p.m., and presided.

### Chamber Emergency Evacuation Plan Announcement and Citizen Speaker Guidelines

Assistant City Clerk Rebecca Sullivan provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency along with citizen speaker guidelines.

### Public Comment Period

Christopher May expressed his concern with Richmond Police response to emergency calls and crime in his neighborhood of Oak Grove.

*Chair Reva Trammell expressed her concern for the issue and suggested collaborating with Mr. May and the Interim Police Chief in order to discuss solutions.*

*Member Kristen Nye shared her concern regarding police response availability.*

Interim Chief of Police Rick Edwards discussed the issues facing the Richmond Police Department (RPD) that may have contributed to Mr. May's experience. Specifically, Interim Chief Edwards highlighted the geographical layout of current police precincts, RPD staffing practices, and population growth in the city.

*Member Nye suggested further discussion of the issue at the upcoming Public Safety Committee Meeting in April 2023.*

## Discussion Item(s)

### **Speeding Mitigation**

Interim Chief of Police Rick Edwards shared a presentation on the Richmond Police Department's (RPD) efforts to mitigate speeding and enforce traffic safety. Interim Chief Edwards stated that the RPD's actions aimed to specifically lower the amount of deadly traffic crashes in the city.

*Member Kristen Nye asked what actions her constituents could take to help aid traffic reporting and safety. Member Nye also inquired as to how the RPD could effectively enforce traffic safety, especially the speeding issues within the city.*

Interim Chief Edwards stated that more reporting allowed the RPD more time to prepare for successful enforcement. Interim Chief Edwards suggested that the RPD could switch tactics for traffic safety enforcement, such as seizing vehicles involved in speeding or reckless driving reports. Interim Chief Edwards also stated that in order to move forward with such actions, however, the RPD would need guidance from the Office of the City Attorney.

*Chair Reva Trammell shared her concern that traffic safety was a growing issue in the city.*

*Member Nye inquired if it was possible to involve the Office of the City Attorney in collaboration efforts to help the RPD find alternative solutions to traffic safety enforcement and regulation.*

Fire Chief Carter stated that a report would be available for the upcoming April 2023 meeting.

*Vice Chair Ann-Frances Lambert shared her appreciation for the Fire Department and suggested the possibility of coordinating more outreach between first responders and local residents.*
