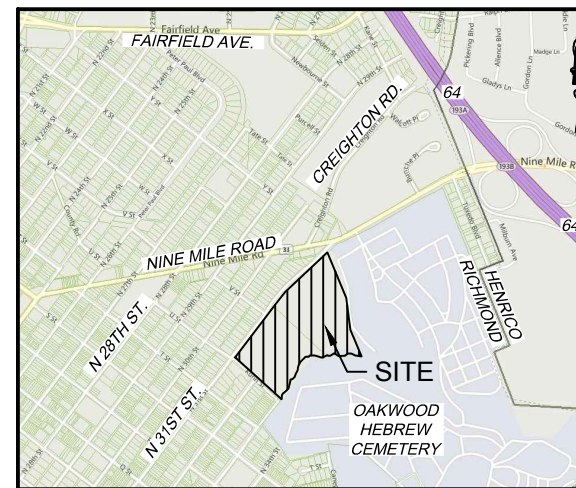
The property embraced within the limits of this subdivision is that property conveyed to THE CITY OF RICHMOND:

- And from Conrad Jacob Feitig, et al, by Petition and Order dated the 8th day of April 1946 and recorded at the Clerk's office in the Circuit Court of the City of Richmond, Virginia on the 7th day of August 1946 in Book 484B on Page 490. See Department of Public Works Drawing Number O-11943, dated the 19th of March, 1954 for subsequent agreed upon property line changes.

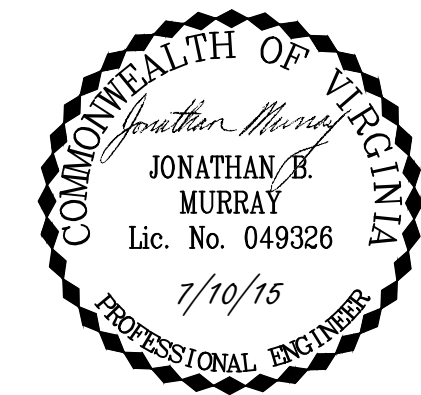

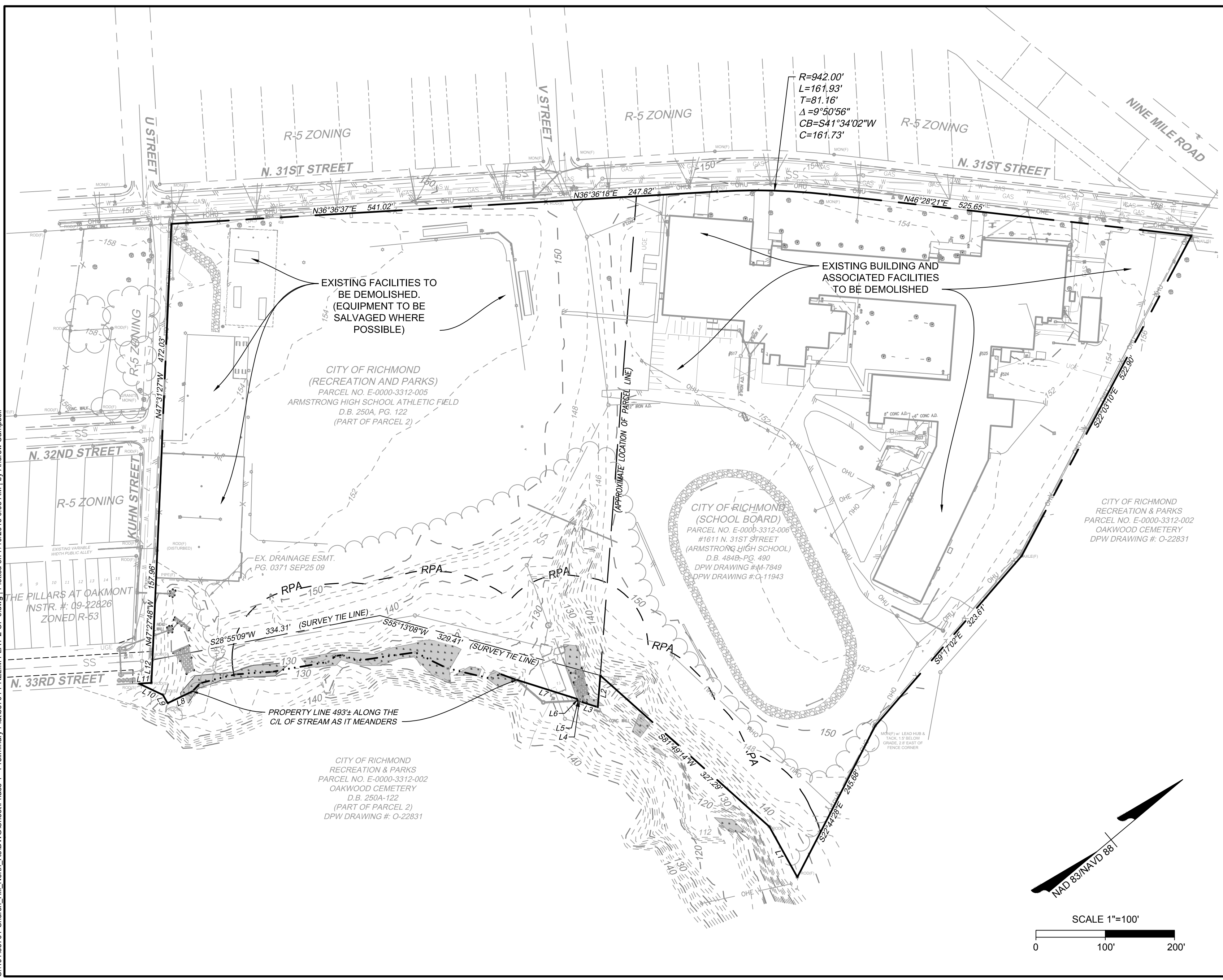

- Property within the limits of this subdivision is located in Zone X, areas determined to be outside the 0.2% annual chance floodplain, as shown on the FEMA Flood Insurance Rate Map Number 5101290042D for the City of Richmond, dated April 2, 2009.
- Property within the limits of this subdivision contains wetlands. A wetland delineation was performed and GPS located on September 22, 2014 by Timmons Group. Flags were later field located by H&B Surveying and Mapping, LLC. The location is shown on the plans. The designated wetlands do not extend beyond the tops of banks of the creek.
- Property within the limits of this subdivision is located in Chesapeake Bay Preservation Areas designated by the City of Richmond, Virginia pursuant to Chapter 50 of the City Code of 2004. A perennial stream determination was performed in June of 2008 by Timmons Group. The wetland delineation was used in conjunction with the stream determination to determine the limits of the Resource Protection Area which is denoted on the plans.
