Council President Cynthia Newbille called the meeting to order at 6:08 p.m., and presided.

Invocation was offered by Pastor Larry Miles Sr., of Fresh Anointing Cathedral Church of God in Christ (COGIC), 3001 2<sup>nd</sup> Avenue, Richmond, VA.

Members of Council and the audience recited the Pledge of Allegiance.

## **ELECTRONIC MEETING ANNOUNCEMENT**

City Clerk Candice Reid, in accordance with Ordinance No. 2020-093, adopted April 9, 2020, announced the meeting would be held through electronic communication means. City Clerk Reid stated notice of the meeting was provided to the public through a public information advisory issued on June 15, 2020, and through Legistar on the city website in accordance with usual practice. She also stated members of the public were encouraged to provide comments in writing prior to the meeting and all comments received prior to 10:00 a.m., on Monday, June 22, 2020, were provided to Council members. Ms. Reid indicated that members of the public who signed up to speak and provide comment would be called to speak at the appropriate time.

#### **CITIZEN SPEAKER GUIDELINES**

Councilor Michael Jones moved to suspend Council's Rules of Procedure and to allow five minutes for citizens to speak during the Citizen Comment Period, which was seconded and approved: Ayes 7, Jones, Robertson, Larson, Lynch, Addison, Hilbert, Newbille. Noes None. Gray had not yet arrived.

Councilor Kim Gray joined the meeting at 6:15 p.m.

Upon the President's request, Deputy City Clerk RJ Warren provided citizen speaker guidelines.

#### APPOINTMENTS AND REAPPOINTMENTS

There were no appointment/reappointment items for consideration.

#### **AWARDS AND PRESENTATIONS**

There were no awards or presentations.

## CITIZEN COMMENT

Citizens were provided an opportunity to offer comments in writing prior to the Formal City Council meeting. All written citizen comments received by the Office of the City Clerk were provided to members of the Council prior to the meeting, and are included as an appendix to the June 22, 2020 Formal City Council meeting minutes.

Charles T. Peters III addressed Council and requested the following:

- The reopening of the Marcus-David Peters case
- The defunding of the Richmond Police Department (RPD), and the reallocation of RPD funds towards a *Marcus Alert System*, civilian review board (CRB) independent of the RPD, human services, the environment and general community welfare
- The release of protesters with all pending charges dropped
- The removal of all monuments symbolizing white supremacy
- The release of the names of RPD officers under misconduct investigation since May 29, 2020

**Christopher Gayler** addressed Council and expressed his concerns regarding the use of force and military style equipment by the RPD. Mr. Gayler inquired why Council's Public Safety Standing Committee had not met since February to address public safety in the city.

**Luca Connolly, Richmond Community Bail Fund (RCBF) co-director**, addressed Council and informed Council that the RCBF provided funds for individuals unable to meet cash bail requirements. Ms. Connolly requested Council ask Commonwealth's Attorney Colette McEachin to drop all pending charges against protesters to avoid negatively impacting protesters' lives and diverting funds from city services.

Yohance Whitaker, Richmond Transparency and Accountability Project (RTAP) member, informed Council of RTAP's work to disrupt mass incarceration in the city. Mr. Whitaker addressed the potential of CRB oversight of the RPD, and he stated a diverse task force with meaningful citizen input was necessary in the drafting and establishment of a CRB.

**Princess Blanding, sister of Marcus-David Peters**, addressed Council regarding the establishment of a *Marcus Alert System* that would require that mental health experts be the first responders for emergencies involving individuals experiencing a mental health crisis. Ms. Blanding stated police would only serve as backup support if the emergency scene became unsafe. Ms. Blanding also stated the *Marcus Alert System* would only be successful if the RPD were held accountable for the use of force on peaceful protesters and members of the press.

**Stephanie Rizzi, RTAP member**, addressed Council and informed members of RTAP's efforts regarding civilian oversight of the RPD. Ms. Rizzi stated any CRB should be funded by Council and independent of the RPD. Ms. Rizzi cautioned Council that the mayor's suggested 90-day time period to review and establish a CRB may create a rushed and flawed system. Ms. Rizzi suggested that funds be reallocated from the RPD budget to fund the city's CRB.

Phil Wilayto, Virginia Defenders for Freedom, Justice and Equality (VDFJE), addressed Council and informed members that the VDFJE supported the resignation of former Richmond Police Chief William Smith, but were concerned about the mayor's selection of Major William "Jody" Blackwell to serve as interim police chief. Mr. Wilayto stated the public should be involved in the vetting and selection of the next permanent police chief. Mr. Wilayto also stated public engagement in the selection process would help reestablish trust between the RPD and citizens.

**Dr. Aubrey Jones, Richmonders Involved in Strengthening our Communities (RISC) member**, addressed Council regarding the lack of affordable housing in the city. Dr. Jones stated that affordable housing would produce secure and safe environments for families. Dr. Jones expressed his concerns regarding the upcoming end to the temporary moratorium on evictions due to the COVID-19 pandemic.

**Dr. Pam Smith, RISC member**, addressed Council and informed members of the experiences citizens encountered regarding affordable housing and gun violence in the city.

**Steve Saltzberg, RISC member**, addressed Council and expressed his concerns regarding gun violence within the city. Mr. Saltzberg informed members of the *Group Violence Intervention* strategy and stated the violence reduction strategy could help decrease gang and gun violence within the city.

*Janice Lacy, RISC member*, addressed Council and informed members of the experiences citizens encountered regarding joblessness and the fear of homelessness. Mr. Lacy requested Council use funds provided by the CARES Act stimulus package to address affordable housing issues in the city.

Marty Wegbreit, Affordable Housing Trust Fund Oversight Board member, Eviction Task Force member, and RISC member, addressed Council and expressed his concerns of the potential for an eviction tsunami if the temporary moratorium on evictions came to an end. Ms. Wegbreit stated Council should declare affordable housing as the first priority to receive any potential surplus funds the city may have. Mr. Wegbreit spoke to the importance of housing availability for individuals who needed to shelter in place during a pandemic.

**Nancy Kunkel, RISC member**, informed members of potential uses of funds provided by the CARES Act stimulus package regarding affordable housing and eviction diversion. Ms. Kunkel addressed steps taken by the city of Alexandria to distribute funds the city received from the CARES Act to address housing issues.

**Pastor Ralph Hodge, Second Baptist Church senior pastor, and RISC member,** addressed the reallocation of RPD funds and resources towards proactive solutions that would help strengthen the community. Pastor Hodge stated the *Group Violence Intervention* strategy and the reimagination of policing were necessary in the city. Pastor Hodge also stated that RISC had requested the mayor allocate CARES Act funds towards affordable housing and eviction diversion.

**Mark Shubert** addressed Council and expressed his concerns regarding the RPD's use of force on citizens within the city.

**Emily Bradley-Kane** addressed Council and expressed her support for the reallocation of RPD funds. Ms. Bradley-Kane requested Council reallocate RPD funds towards a *Marcus Alert*, schools, affordable housing, substance abuse treatment and other community focused programs.

**Carlisle Bannister** addressed Council and informed members he felt unsafe leaving his house during the current social unrest within the city.

**Lawrence D. Meyer** addressed Council and stated he was saddened by the current crisis in the city. Mr. Meyer also stated open dialogue was necessary from all sides to find solutions. Mr.

Meyer requested that citizens allow the legal process to take place regarding the removal of Confederate monuments.

**Jer'Mykeal McCoy** addressed Council and expressed his concerns regarding the use of force by the RPD. Mr. McCoy also expressed his concerns regarding the selection of Major William "Jody" Blackwell to serve as interim police chief. Mr. McCoy requested the reallocation of RPD funds towards community services and that the RPD only respond to violent situations and not situations involving mental health crises.

President Cynthia Newbille stated Council appreciated the comments provided by citizens and indicated that Council would address many of the issues citizens raised at upcoming committee meetings and forums.

# **Public Hearing**

# Opposition

**Thomas Courtney** spoke in opposition of Ord. 2019-343 and requested that Council not adopt the proposed ordinance as written. Mr. Courtney stated the ordinance did not provide any benefit to the city, and he suggested Council refer Ord. 2019-343 back to the City Planning Commission for possible revisions.

**Stacie Vanchieri** spoke in opposition of Ord. 2019-343 and stated if the proposed ordinance was adopted as written, it would decimate the short term rental (STR) business model within the city. Ms. Vanchieri also stated STRs are the preferred choice of young tourists visiting the city. Ms. Vanchieri further stated Ord. 2019-343 had many flaws and the ordinance would not help generate revenue for the city.

**Tyler Rackley** spoke in opposition of Ord. 2019-343 and stated he believed the proposed ordinance would be highly destructive, because it would eliminate nearly 80% of existing STRs within the city. Mr. Rackley also stated Ord. 2019-343 would not benefit the city because it would not create any tax revenue that could be used for city services such as affordable housing.

**Troy Kingsbury** spoke in opposition of Ord. 2019-343 and stated he believed that STRs had greatly benefited the city. Mr. Kingsbury also stated the proposed ordinance would harm the continued grow of the city and discouraged tourism. Mr. Kingsbury suggested members research *NiidoHomes*, apartment style STRs, which provide a hotel alternative for tourists. Mr. Kingsbury referenced a currently operating *NiidoHome* he visited in Nashville, and expressed his belief that these were the types of housing options young tourists desired.

# Support

*Jerry Beverage, Fan District Association (FDA) member and former president,* spoke in support of Ord. 2019-343 and stated the FDA also supported the proposed ordinance. Mr. Beverage also stated Ord. 2019-343 would help protect homeowners and residents within the city by preserving the residential character of neighborhoods.

Mark Olinger, Department of Planning and Development Review director, provided Council with additional information regarding the drafting and legislative history of Ord. 2019-343. Mr. Olinger cautioned Council that without the restrictions referenced within the proposed ordinance, large corporations and hotel operators could begin to buy multiple single family homes and apartment buildings to operate unregulated STRs within established neighborhoods. Mr. Olinger stated he believed Ord. 2019-343 was a good first step to begin the legal operation of STRs within the city.

Councilor Stephanie Lynch stated she believed amendments could be added to Ord. 2019-343, which would promote code enforcement, protect neighborhoods, create taxable revenue for the city and establish parameters to guardrail against large scale corporate run STRs. Ms. Lynch also stated she was concerned the ordinance would negatively impact the local economy.

Councilor Kristen Larson inquired about the taxation of STRs.

John Wack, Department of Finance director, informed Council that there was no current proposal to change taxation regarding STRs, because STRs have yet to be declared legal within the city. Mr. Wack stated city administration was also concerned that it would cost more to collect a new tax than what could be collected in revenue from any newly applied STR tax. Mr. Wack also stated he did not anticipate the city proposing a STR tax if the primary residency requirement was approved.

Vice President Chris Hilbert expressed his support for Ord. 2019-343 and stated he believed a tax regarding STRs should be implemented.

Councilor Ellen Robertson shared her concerns regarding the impact Ord. 2019-343 would have on current operators of STRs that are not primary residences. Ms. Robertson inquired if it was possible to "grandfather" current operators of non-primary residence STRs, if the ordinance was adopted.

Mr. Olinger informed Council that the "grandfather" option was discussed, but it was not possible. Mr. Olinger stated that was because the current operation of any STR was illegal, and illegal operations cannot be "grandfathered" into a legal enterprise.

Councilor Michael Jones stated he understood the necessity of a policy regarding STRs, but added he was aware of the impact it would have on the many operators of STRs.

Councilor Kim Gray stated she was disappointed that Ord. 2019-343 did not address taxation of STRs, but she believed the ordinance was necessary and a good starting point.

There were no further comments or discussions and **ORD. 2019-343 was adopted:** Ayes 6, Robertson, Larson, Gray, Addison, Hilbert, Newbille. Noes 1, Lynch, Abstentions 1, Jones.

Sharon Ebert, Department of Economic and Community Development deputy chief administrative officer, provided an introduction of Res. 2020-R034, and informed Council that the resolution was amended to remove all city-owned property with the exception of the Public Safety Building located at 500 North 10th Street.

Leonard Sledge, Department of Economic Development director, stated the unsolicited offer for the city-owned property by Capital City Partners, Inc., presented the city with a redevelopment opportunity that would attract businesses to downtown and create more taxable revenue for the city.

Councilor Kristen Larson inquired if there was an appraisal of the property referenced in the resolution.

Mr. Sledge informed Council that an appraisal was conducted, but city administration was reluctant to release that information due to the potential negative impact it could have on negotiations.

Councilor Ellen Robertson expressed her support for Res. 2020-R034 and the redevelopment of the area referenced in the resolution.

Councilor Kim Gray suggested Council and city administration examine a potential land lease of the city-owned property rather than a complete sale. Ms. Gray requested city administration keep Council informed of negotiations regarding the sale of the property.

Mr. Sledge stated city administration would negotiate to create and accept the best deal available for the city and citizens.

There were no further comments or discussions and **RES. 2020-R034 was adopted:** Ayes 8, Jones, Robertson, Larson, Gray, Trammell, Addison, Hilbert, Newbille. Noes None.

### Dear Council Member:

I've lived in the city of Richmond since 1970. For these many years, I've travelled up and down Monument Avenue for a variety of reasons, not really paying attention to the statues. To be quite honest, it's difficult to pay attention to them while you are driving, trying to get around them without an accident.

I understand the need to move them, although I certainly thought they would have been put in context by now when that was agreed upon over two years ago. However, money to move the statues should be a great consideration. Over the years, projects such as the 6th St Marketplace, Main Street Station, Redskins training camp, etc., have displaced money from the public schools in the city. The monuments issue could also divert money and attention from one of our most important needs.

So more specific thoughts.

First, it would be helpful to move them with respect, which I think you plan to do. There is a lot of anger in regard to this issue, and I think the city needs to be thoughtful as it deals with this and other related issues and try to diffuse the situation.

Also, I don't think adding statues of people on Monument Avenue would help. I think it would just make citizens more angry and upset and, again, divert attention from education and other needs of the city. Leaving those statues north of Arthur Ashe Boulevard to remain would be an ideal opportunity and an example of putting both statues in context. Maury was a scientist, naval officer, and spent most of the Civil War abroad, and made many positive contributions to science, including charts of winds, whales, currents and ocean travel. Arthur Ashe's athletic contributions could be highlighted as well. Both Maury and Ashe could focus on education.

## Suggestions for replacements:

• Primarily to make the areas educational beyond race, beyond the Civil War, even beyond people – a focus on Virginia and its geological and natural history.

- Extinct animals, e.g., the mastodon, 12,000 years old, found in Yorktown not too long ago; a pile of oyster shells as big as a man's foot (according to John Smith – but feet were smaller then), perhaps a nice vertical rendering of the state fossil, the Chesopecten jeffersonius.
- Some kind of map, e.g., on the ground like the one at the Virginia Institute of
  Marine Science which shows the Chesapeake Bay with different types of stone,
  but this one would show the James River area; perhaps a large rendering of John
  Smith's map of Virginia, which includes the presence of Native Americans; a
  globe showing Richmond in context of the world.
- Perhaps a small representation of the physical geography of Virginia, from the coast to the mountains, east to west.
- Local animals what we see in our neighborhoods possums, raccoons, squirrels, cats, dogs, etc., come to mind with a fountain (perhaps at the Jefferson Davis site) that could be enjoyed during the many gatherings on Monument Avenue, e.g., the Easter Parade.

Let people see our history – but a different kind of history. What Virginia has given and could give to the people – but NO people as monuments. History is yesterday, and we need to move on. This could be a cooperative project, engaging Richmond citizens, artists, and historians – and Richmond's young people in schools, bringing them together to resolve an issue of concern to many and an opportunity to appreciate the good things we have.

And there will be less misunderstandings in the future if there is better education and critical thinking now. Education should come first.

My comment is as follows:

"As a disturbed Richmond citizen who has witnessed a complete lack of leadership in my elected officials over the last month—from your coronavirus response, to the civil unrest and numerous cases of police violence—I would like to express and refocus your attention to some key concerns, which are essentially unacknowledged by any legislation on this current meeting's docket. Echoing the public demands of many other Richmond citizens, I strongly encourage you to:

- 1. Re-open the Marcus-David Peters Case.
- 2. **Defund the Richmond Police and Sheriff's Office entirely.** Reallocate these funds into Human Services and Education. Revitalize a Care Economy in a city that so desperately needs it.
- 3. **Drop all charges against every protester, regardless of the charge's nature**. There can be no rightful or even lawful arrests when your officers have in-mass brutalized and agitated the general public so severely over the last month. They cannot be trusted, and therefore, you cannot punish citizens for their unique responses to these terrorizers and the wrongful legislation that further condoned this gestapo-esque behavior.
- 4. Establish a Civilian Review Board with subpoena powers, separate and completely independent of the Richmond Police Department and Sheriff's Office. It goes without saying that these officers are trained to be afraid, violent, and essentially useless at their once core-duty: to *protect* and *serve* the *community*. Therefore, we need complete *community* oversight.
- 5. Release the names of the RPD officers that are currently under investigation for misconduct.
- 6. Remove all confederate monuments.
- 7. Give complete and total rent amnesty to those facing evictions, and

**suspend all future rent/mortgage payments for the duration of this global pandemic.** Despite popular belief, the coronavirus will *not* be over by June 28th —the end of the eviction moratorium. Going through with these evictions and forcing vulnerable people into even more precarious financial/living situations during a viral epidemic is a health-risk to *everyone*. Please protect the people of Richmond. Stop punishing citizens who cannot even afford to live right now.

All that being said, there are a *few* items on this meeting's docket which vaguely intersect with the demands above. Those being:

**ORDINANCE No. 2019-275 and No. 2019-276** — establishing a Technology Zone and giving bizarre tax breaks to these future tech workers—essentially outsourcing Richmond's current economy to profit-hungry businesses that have absolutely *no* interest in bettering our communities. It feels redundant to say that this is a sloppy, quick-fix attempt at economic revitalization. We already know what happens to cities *just* like Richmond that use this approach—paving the way for gentrification. No matter how well-intentioned this approach might be, how can you reconcile the outcome which will likely mirror that of Seattle, San Francisco, Boston, Houston, etc...? If your intentions are to revitalize our economy, why not invest in the business sectors and workers that already *carry* Richmond? Why not raise the minimum wage? Why not invest in affordable housing? Why not provide better safety nets for the Richmond citizens that are statistically most likely to be pushed out by this hasty decision? If what you view as a successful Technology Zone involves negatively impacting and displacing <u>any</u> percentage of the RVA population, where do your priorities truly lie as elected officials? I encourage city council to do much better, and find a different approach to this problem.

The following are changes I would like to see made in light of recent events in the city.

First, the city should drop ALL charges and fines against protesters. If there is evidence of looting, robbery, etc, fine, but for those people involved in protests against the killing of George Floyd and so many other Black citizens at the hands of police, drop all charges.

Second, the city needs to begin investigations of all officers involved in pepper spraying, tear gassing, or assaulting a citizen with a vehicle, and remove from active duty any police officer currently under investigation for said activities. That investigation should be carried out with members of the public/community (i.e. not the police or current administration) involved.

Third, the city should institute a policy disallowing hateful tattoos on members of its force, such as that worn by Lt. Brian Prendergast on his left forearm quite openly touting Nazi ideology. Fourth, the city should ensure that the hiring process ensures that members of hate groups and similarly otherwise unfit officers are not recruited to the force. Fifth, the city should change its police policy in a number of ways, enumerated below.

First, use of force policies in general should be reviewed and significantly altered, so that citizen safety is prioritized over officer fear. Policy regarding crowd control should be codified if it is not already, and should disallow the use of tear gas, pepper spray, mace or other irritants; flash grenades, rubber bullets, and any other weapons which officers have used with remarkably poor judgement, likely due to poor training and discipline.

### To the Richmond City Council,

My name is Jessie Gemmer, and I am a lifetime resident of Richmond. These past few weeks are the first time I have been truly proud to be a Richmonder because it is the first time I have heard the voice of the people of the city. It is so much richer, stronger, and more passionate than anything I knew existed in Richmond. The more I learn from these voices, the more angry I am at how much needs to change and how little has been done to care for our most disadvantaged citizens. I include myself in this neglect.

People are protesting to get your attention. Don't ignore us. We would do anything to have the kind of power you have. We cannot boycott the police - we pay our taxes dutifully and you allocate where it goes. We have no recourse for economic sanctions so our only resort is to be annoying and loud enough that you will enact change just to get us to go away. I am optimistic, though, and I pray that this sea change of social activism will allow you all to act on your inner angels and do the things that made you want to be politicians. I hope and imagine that you want the best for this city, and that you are aware of the injustices forced on our Black community members and are actively working to correct those wrongs. I am excited for you to seize this opportunity to create real and meaningful change. Please do not let it pass by.

My husband is a teacher in Richmond Public Schools at Elkhardt-Thompson Middle School. You know what that means. He teaches classes primarily populated by children with IEPs to address their - predominantly emotional - disabilities. You know why they are traumatized. The school is rotting, and though I am glad it is moving to a new facility, it breaks my heart that they ever attended a school that showed them in such a clear physical demonstration that they are not important. When my husband started his school year last fall, I helped him decorate his classroom. We painted the peeling cinder block walls and rusty metal, brought in plants with grow lights to hide the fact that there were no windows, and hung colorful posters to distract from the mold and broken desks. Another teacher told us that the horrible appearance of the school was identical to the horror appearance of their homes, and that she beautified her classroom to give her students an hour a day where she could show that she cared enough about them to care for their environment.

As an architect, I believe that the physical appearance of our world forms us just as we form it. I see the city being shifted from a gritty post industrial landscape to a shiny and generic replica of every other city in America. We aspire to look successful in order to show that we have evolved. And on the fringes of that sparkling monotony are the people forced out by the development, living in squalor and horror. The same kids who get dragged out of the cafeteria by SROs go home and watch their parents get dragged out of their communities by police officers. They go from falling apart schools to falling apart homes. It seemed to me, until

these past few weeks, to just be the way the world works.

But right now, you all have a chance to change the way the world works. I listened to the last City Council and School Board meetings, and I saw the crack in the wall with light shining through. Do not compromise; do not incrementally roll out ideas that are palatable to the nameless majority. Be bold, be brave, and be loving in your decisions. Be good ancestors.

I know you're getting a lot of these letters, so I won't belabor the points about action. You know that the budget is being decided. You know that in order to improve the lives of your poorest constituents, you must take money from the police and redistribute it to social programs. You know that uniforms and weapons do not belong in schools. You know that allocating almost TWENTY NINE TIMES more money to the police than Housing and Community developments is a clear demonstration that you care more about cleansing society of people who aren't "acceptable" to society than supporting them so they aren't destined to live the same lives as their parents. (RPD's total general fund was \$95,403,743 while Housing and Community Development's was \$3,296,705). Where is the loving care for the homeless? Where is the empathy for the mentally ill? You can change it all.

I want to end this letter by strongly denouncing the actions of the RPD these last few weeks. I've talked to people who experienced their brutality. I've watched hundreds of videos and read dozens of accounts. I've also read the RPD's and Mayor's statements on those situations. They do not match up, and you know it. The police are human beings, just like the protesters, but they are allowed all the good faith and protection you have, while the protesters are condemned and lied about. These are not outside agitators - these are YOUR citizens. We are your people, and we are not going to allow the status quo to continue.

I hope someday to tell my children about this period in Richmond history with pride. I'd like to tell them your names, to relay how our city's leaders came together to set the example for the entire country for how to form a society for all people. I will do everything in my power to help create change. I insist you do, too.

### Good evening councilmembers,

I am writing to stress, as strongly as I can, how excessive and unacceptable the response of the Richmond Police Force and their associates have been to the protests against police violence taking place in our city thus far. I, like many in this city and across the world, feel outraged at the current state of policing in this country. I was once under the impression that the purpose of a police force was to protect members of the community against those who may wish to harm us. It is now apparent to me, based on my own experience with the police combined with the countless filmed encounters of their interactions with others, that the largest and most terrifying source of violence in this city is the police department itself.

I have never been so fearful and so traumatized than I have while trying to exercise my First Amendment right to free speech and assembly when Richmond's police force is present. I have never seen such a grotesque false equivalence constructed whereby the smallest transgression by a civilian protestor seems to justify the limitless deployment of violence and destruction by the police. It has come to my attention that the reason the police chose to launch tear gas, rubber bullets, pepper bullets, paint balls, flash grenades, mace, and pepper spray indiscriminately across the crowd was because, according to them, water bottles were thrown in the direction of the force. I have never thrown anything at the police. I have never seen or heard of anything being thrown at the police. I, like the vast majority of the protesters on the street, remained entirely nonviolent during these interactions. So why do I get traumatized trying to flee to safety while police shoot tear gas in the direction of every escape? My rights do not hinge on the behavior of others. But all it takes is a few moments on the ground at these protests to see how the officers on the line simply wait for a single civilian transgression so they can launch their attack on the entirety of the crowd.


Wherever any reasonable person would draw the line between reasonable and excessive police tactics, Richmond police has shown time and time again that that line has been crossed. There is a bounty of filmed evidence of each encounter showing an absolute overwhelming and violent response to protesters at the slightest provocation, if such a provocation occurs at all. Every time I leave these protests I feel confident that my elected officials will finally see how inappropriate and aggressive the actions of RPD have been that night. Every day I wake up to find that the media and the mayor have come to their defense, choosing to believe the word of the officers rather than the videos and testimonies made by civilians. To me, it is this clear message that the police allegations get the benefit of the doubt while civilian allegations get entirely dismissed that has been the greatest disappointment of all.

Mayor Stoney and Chief Blackwell continue to argue that protesters refuse to meet and speak to them civilly. I have called both of these officials' offices numerous times, nearly every day

since the start of these protests, requesting to do just that. I have yet to hear back from anyone.

At this time, I am urging City Council and Mayor Stoney to have the courage to grasp the full breadth of the cruelty and needless violence that the Richmond Police Department continues to wage against protesters with impunity. I am begging for someone, anyone, to acknowledge that no actions taken by the protestors justifies this sort of response by the police. I demand that Mayor Stoney take the explicit video evidence filmed from the ground with the same seriousness as he takes RPD's statements about chemicals and other substances being thrown at police. I demand such allegations made by police be verified publicly. I demand that the same respect and concern that the Mayor gives to the perspective of the police also be given to the perspective of civilian protestors, which heretofore have been entirely excluded from the Mayor's statements. I demand that City Council hold Mayor Stoney, Chief Blackwell, and the Richmond Police Department as a whole to a far higher standard than has been upheld thus far. All of you, each and every one of these entities, are supposed to be working to the benefit of Richmond residents. Time and time again my experience has been the opposite.

Late-night unlawful individuals have been allowed to (1) openly and continuously vandalize both personal and public owned property, (2) break windows, damage cars, and damage businesses, (3) take-over streets by being on both sides with people crammed in the car and riding on top, driving wreck-less, yelling, screaming profanity, and honking until all hours, (4) release explosives and fireworks in residential alleys and on streets, on public roads and community owned areas, at all hours (4 AM on Saturday) (5) set up overnight sleeping without any health considerations, (6) openly use drugs and alcohol (just take a late night walk to Lee), and (7) openly display weapon (sticks, bats, and GUNS).

All elected officials have a moral, civic, and sworn duty to uphold the law. They must do this no matter their opinion or political position. This isn't just for residents and businesses. On multiple occasions, I have watched cars unknowingly drive into large groups of people, all in black, on skateboards and bicycles. This is an example of why protests must be lawful. The Mayor's failure to act is dangerous to everyone - residents, businesses, protesters, and the police.

I also want to specifically address Ms. Stephanie Lynch and Dr. Michael Jones. Both of you have repeatedly and publicly stated the protests are peaceful and you have verbally attacked the police. I was at Stuart Circle last night viewing the events. Your comments were not true. We witnessed an angry group, charging and running at police, throwing hard objects, and screaming/yelling trying to incite a riot. The police set up a perimeter and repeated the announcement the event was unlawful and asking the group to disperse. All these warnings were ignored. So what is your suggestion? How are the police to set reasonable and lawful boundaries to protect the City while angry groups do whatever they want at any hour of the night? I am not taking about future reform - I am asking about now, about tonight? If you are unwilling to act now, at minimum, be honest in your comments.

# Good Afternoon,

It is out of an abundance of concern and absolute frustration that I find myself writing to you today. Throughout the past three weeks, and continuing even as you meet today, it has been my honor to stand beside my Black brothers and sisters as they protest to demand equal treatment under the law. In that time the egregious mismanagement, and, far too often, cruel implementation of Geneva convention barred "crowd control" measures by Richmond Police Department has been appalling. They have attacked innocent protestors, have countlessly disregarded their own protocol on crowd control threatening the safety of citizens exercising their first amendment rights (including children), and have lied repeatedly in the press as well as by way of their social media channel, to discredit, villainize, and misinform the people of Richmond, Virginia. Throughout this same time, as our elected officials and law enforcement officers continue to fail us, I have seen our community come together in ways unmatched by anything I have seen in this city. Medic teams, that care for injured protestors, often by placing their own bodies in harm's way, Bike Marshalls, that control the flow of people and traffic, standing between protestors and incoming, potentially lethal, vehicles such as the one that mowed through a crowd of peaceful protestors in Charlottesville in 2017, ending the life of ally Heather Heyer as she marched against racism and in honor of Black lives. I have seen supply tents, offering everything from masks and sunscreen to full meals, all donated from the deep hearts and personal bank accounts of citizens still facing daunting financial uncertainty as we continue to suffer the effects of COVID-19. I have witnessed the people of Richmond rise up and care for one another. They do so in your absence.

I would not be so presumptuous as to attempt to tell you how to do your job. It is with good faith each of you was elected to City Council, and with that, we have entrusted each of you with the job of caring for and protecting, all citizens in Richmond. Your constituents are in danger. Daily we face over-militarized police who use tax-funded weapons to terrorize the very people you, and they, have sworn to protect. Should you find yourself questioning how to better serve your community, I invite you to attend any of the marches. Do so without the press, or large contingencies of staff and security. Come as a citizen. Watch the work of the people as they re-learn what community looks like, and what it means to be a member of one that values and supports all members. I promise you will return to your office in City Hall with new eyes, softened hearts, and the same fire raging in all of our guts that reminds us we all can do better.

In the same openness and transparency with which you are invited, invite. There is a wealth of subject matter experts available to you as you reconsider Richmond City's relationship

with the Police. Make room at the table for the people. It is, after all, by the people, that you were entrusted with your own seat.

#### Greetings Madam President,

My name is Allan-Charles Chipman. I am a resident of the 6<sup>th</sup> district. I am not able to join you in person today, as today is my one-year wedding anniversary. This past weekend we also celebrated Father's Day. I am writing today because in 2002 a father & soon to be husband, & air force veteran was approached & ultimately killed by two gunshots in the back. The man killed was named Jeramy Gilliam. The man that killed him is the current police chief William V. Blackwell. The police chief shot Mr. Gilliam despite Mr. Gilliam not matching the description and despite the fact that his prints were never found on the gun used to "justify" the shooting. The family of Mr. Gilliam was informed in 2002 that Officer Blackwell would no longer be with the Richmond Police Department. Yet much to the surprise of Jeramy's family, not only was Officer Blackwell not ousted by RPD, but now, per the selection of Mayor Levar Stoney, is now the Chief of Police. On June 20,2020 the family of Jeramy stated "Jeramy loved his son & his son was robbed of his Father's Love." This is due to the actions of the current police chief & system of policing where if you take the black life of a father & veteran you can rise to the top of the ranks. Such has been the cry of the family of Marcus-David Peters for two years as well. As a trustbuilder, I often teach that the best thing one can do to gain trust is to display trustworthiness. The very presence of Officer Blackwell erodes trust. We face not only a crisis of trust but also a crisis of democracy. Just last night Andrew Ringle of the Commonwealth Times joined a long list of press assaulted by police. Ringle was tear gassed and thrown to the ground despite showing his press pass which also happened to Roberto Roldan recently. Yes even, two members of this body who have put forth legislation to begin the process of defunding police have been teargassed as well.

I stand in support of the process to begin defunding police and reallocating resources to our overpoliced and underfunded communities. However, it disturbs me greatly in the midst of this turmoil that the Public Safety Committee which is one of the few democratic processes with watch over the police has not met since February and has cancelled the June 23,2020 meeting. I call on Council Members Hilbert, Trammell, and Gray to reschedule this meeting for June 23,2020.

As an issue of public safety we must address

- 1. Reopening the case of Interim Chief Blackwell in the killing of Jeramy Gilliam
- 2. Demanding transparency on the disciplinary procedures of the teargassing of peaceful protestors that took place at the Lee statue.
- 3. Demanding transparency on the disciplinary procedures for the officers who ran over protestors with police vehicles. Especially, the case that occurred on 05/30/2020 where no investigation has taken place. I would like to add a special investigation looking into white supremacist ties of the officer given this happened within a string of days of white supremacists using vehicles to assault protestors in Richmond and Henrico.

- 4. Demand transparency on the origins of the "fireworks" and explosives that have been heard in residential areas in the city. This appears to be a nationwide attempt by police such as in Baltimore and other cities for police to be able to report a higher level of calls in the midst of a discussion to defund police. The mayor in his op-ed stated a higher level of calls being received by police. I would like a report to see how many of those calls have been in response to a sound of "fireworks" or "gunshots."
- 5. Removing the requirement from the police use of force board to require appointment by the chief of police (since our current police chief killed a man in 2002) and the requirement of attending the citizen police academy.
- 6. Expressing the necessity of an Independent Community Oversight Board and requesting subpoena power from the Richmond delegation in the General Assembly and other state representatives.
- 7. Beginning to defund police and collaborating with Richmond Transparency and Accountability Project to redirect funds prioritizing the overpoliced communities.
- 8. Redirecting the funds gained by civil asset forfeiture and having those redirected to initiatives that will benefit over policed communities.
- 9. As stated by Councilmembers Lynch and Jones, to move expeditiously in removing the confederate monuments and other iconography dedicated to the ideology of white supremacy.
- 10. Restricting the use of tear gas and other chemical weapons of warfare that restrict respiratory capacity during a global pandemic such as Covid-19 that targets the respiratory system.

I strongly suggest and join in advocating for the demands put forth by the family of Marcus-David Peters since 2018 and reiterated in recent days. This includes advocating to free those who have been arrested while protesting police brutality. Many of these protestors were denied the rights to see lawyers and still have not had charges dropped. We are responsible for what we ignore.



I will let a brief summery of my experience speak for itself.

In January and February things were looking pretty good for my Airbnb business most weekends were booked thru September.

When the pandemic lockdown was announced every single booking canceled!!! I was sure there was no way I was going to make ends meet.

10 days into the lockdown I got a call from an elderly couple that were scared, they wanted to be close to family, their grandchildren, knowing it would be unwise to share the same house they contacted me.

Then a army contractor who didn't feel he could go home to his family after traveling abroad booked.

Three weeks into the lockdown I was contacted by another older couple that wanted to be close to family, then two young professionals that were finding it impossible to work at home with 3 other roommates all trying to Zoom at the same time.

In the middle of this my daughters all decided they wanted to come home, having the space to be together but still safe was an important factor in their decision to travel home.

I have since hosted a traveling nurse a family that found there apartment to small now that the entire family was home and working from home.

None of these guests wanted to go to a hotel and get in an elevator. They couldn't risk being exposed to large groups of people in confined spaces.

None of them wanted to leave their neighborhoods and disrupt there lives any more than they had already been disrupted.

These last months have given me new insight into the value these flexible short term rentals bring to a neighborhood and our city.

I have been in contact with other hosts during the lockdown, as we try to best accommodate our guests. I have learned my story is not unique in fact is seems to be the norm.

I wanted to give you my perspective on short term rentals in our city and describe certain instances where there have been numerous problems with the airBandB right next door to our home.

We, and our neighbors, have had to call the police numerous times over the last 2.5 years because of late night parties and noise at this airBandB. People rent it then invite many others over and it's a convenient place for them to party.

We have spoken with the owner numerous times and let him know what is going on. During one instance the owner replied to us that he was aware (because he has installed cameras) that there was a party going on and he was trying to make them leave but could not reach the person who rented it. One of our neighbors called the police at 12:15 a.m. as the party continued.

I have made complaints to the zoning commission and our council member Kristen Larsen, who has actually met with our neighbors and we appreciate her input.

The owner of this airBandB next to us does not live there. I believe he lives in another state. He has not been there since the first week of January 2020, and for many years before that he was only there sporadically.

It seems inevitable that the short term rental will pass, but I ask that you incorporate into the rules that the owner must live there at least half of the year. I also think you should be charging an occupancy tax and a higher fee for registration and a large fine imposed on owners who violate the rules.

It seems to me you will need this extra money in order to hire people or make a new department to oversee the short term rentals. As a taxpayer, my money shouldn't be going to help them run their short term rentals.

Also, I moved into a residential neighborhood,

not a commercial or mixed use zone. Business is getting into short term rentals now, buying houses specifically for the purpose of making money. How is that not commercial use?
