## **Ordinances & Resolutions for Consideration:**

### PARKS, RECREATION, AND COMMUNITY FACILITIES

1. Ordinance No. 2025-242

**Patron** Mayor Avula

Key Points:

- To authorize the Chief Administrative Officer, for and on behalf of the City
  of Richmond, to execute a First Amendment to Maymont Foundation
  Operating Agreement between the City of Richmond and the Maymont
  Foundation for the purpose of allowing the Maymont Foundation to
  continue managing, maintaining, operating, and improving Maymont Park
  in the city of Richmond.
- The Administration wishes to extend the Agreement one year while it is closely examined prior to longer extensions/amendments.
- While the property is owned by the City, it is operated by Maymont Foundation.
- The Administration's O&R indicates that \$473,000 is expected to be transferred to the Maymont Foundation from the Budget. Members may want to know what the funds will be used for.

#### 2. Ordinance No. 2025-243

**Patron** Mayor Avula

Key Points:

- To authorize the Chief Administrative Officer, for and on behalf of the City
  of Richmond, to execute a Non-Exclusive License Agreement between
  the City of Richmond and FlixBus, Inc. for the purpose of granting FlixBus,
  Inc. permission to use a portion of Main Street at 1500 East Main Street as a
  bus stop, passenger boarding, and waiting area. (7th District)
- Approximately 14 daily trips/stops are made by FlixBus at Main Street Station, which is a multi-modal hub.
- Members may wish to know how the fees charged to Flixbus are established.
- Members may wish to know how many, and which bus companies use Main Street Station as a stop.

### PLANNING AND DEVELOPMENT REVIEW

#### 3. Resolution No. 2025-R045

**Patron** Mayor Avula

**Key Points** 

- To declare a public necessity to amend ch. 30 of the City Code and to initiate an amendment to the City's zoning ordinance to make such lawful changes as may be necessary to establish a civil penalty for the razing, demolition, or moving of a building or structure that is located in a City old and historic district in violation of the City's zoning ordinance, as authorized by Va. Code § 15.2-2306(F).
- Begins Zoning Code changes to allow for penalties up to twice the value of the structure when there is an improper demolition of a historic structure.
- Newly expanded penalties are allowed pursuant to authority granted localities by the General Assembly.
- This paper initiates adding the civil penalty to the City's Zoning Code.
- This paper was continued at the last meeting of the Committee after Committee discussion concluded that discussion might benefit form

4. Resolution No. 2025-R046

**Key Points** 

- Declares surplus and authorizes and request the Chief Administrative
  Officer to seek offers, bids, or proposals by solicitation for the City-owned
  property located at 8790 Strath Road for the purpose of facilitating the
  solicitation of offers by invitation for bids or request for proposals pursuant
  to and in accordance with either City Code Sections 8-61 or 8-62.
- The property was acquired, but never used for gas transmission by DPU in 1994.
- This paper declares the property surplus for purposes of sale.
- Members may wish to know which means of publicizing that the property is available will be used.
- Members may wish to know how many votes are required to dispose of the property by declaring it surplus versus how many votes are required to dispose of the property as proposed in paper number 2025-180.
