(c) For purposes of compliance with 12VAC5-31-420:

(1) The geographic boundaries of the Authorized Provider's primary service area within the city include the entire city of Richmond; and

(2) The Authorized Provider will assist in mutual aid requests from the local government if emergency medical services personnel, vehicles, equipment, and other resources are available.

This ordinance or resolution must specify the geographic boundaries of the agency's primary service area within the locality.
