### Call to Order

Council President Cynthia Newbille called the meeting to order at 5:00 p.m., and presided.

**Councilor Michael Jones moved that the resolution entitled:**

### **RES. 2022-R014**

To express the Council's support, should the citizens of Richmond approve a second referendum for the development and operation of a resort casino, for appropriating one-third of the revenues received as a result of the development and operation of such resort casino to a reserve fund for the purpose of supplanting any decrease in funds received by the School Board of the City of Richmond as a result of adjustments to the Commonwealth of Virginia's Composite Index of Local Ability to Pay.

**be referred to the Finance and Economic Development Standing Committee meeting on March 17, 2022, at 1:00 p.m.**

*Councilwoman Reva Trammell inquired why consideration of RES. 2022-R014 was occurring prior to the General Assembly of Virginia taking any action regarding casinos in the state budget.*

*President Cynthia Newbille informed members, that if the motion was approved, then RES. 2022-R014 would be considered for recommendation by both the Education and Human Services Standing Committee and the Finance and Economic Development Standing Committee, prior to Council considering final action regarding the resolution.*

Chief Administrative Officer Lincoln Saunders stated that city administration was still awaiting action from the General Assembly of Virginia regarding the state budget and casinos.

*Vice President Ellen Robertson stated it was important that Council be consistent regarding the proposed allocation of any revenue received from a casino resort in the city.*
