THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That the sum of \$20,000 is hereby transferred from the unencumbered balance of funds in "Reserve for Contingencies", appropriated in the General Fund Budget and Appropriation Ordinance for the fiscal year 1986-1987 (Ordinance No. 86-118-142, adopted May 28, 1986) to Non-Departmental - Civic and Cultural Activities (General Fund Budget, page 33-1), in order to ~~[offset expenditures incurred for heating and other related expenses in providing shelter]~~ enable the City Administration to purchase and donate food, clothing, medical care and/or supplies and heating oil/gas for the direct benefit of the homeless people and such donations to be made on criteria established by the City Administration, such transfer having been recommended by the City Manager and the Director of Finance having certified that there is a sum not heretofore allotted for a specific purpose in the appropriation made to Reserve for Contingencies sufficient to meet this transfer of appropriation.

§ 2. This ordinance shall be in force and effect upon adoption.

## THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That the sum of \$20,000 is hereby transferred from the unencumbered balance of funds in "Reserve for Contingencies", appropriated in the General Fund Budget and Appropriation Ordinance for the fiscal year 1986-1987 (Ordinance No. 86-118-142, adopted May 28, 1986) to Non-Departmental - Civic and Cultural Activities (General Fund Budget, page 33-1), in order to off-set expenditures incurred for heating and other related expenses in providing shelter for homeless people, such transfer having been recommended by the City Manager and the Director of Finance having certified that there is a sum not heretofore allotted for a specific purpose in the appropriation made to Reserve for Contingencies sufficient to meet this transfer of appropriation.

§ 2. This ordinance shall be in force and effect upon adoption.

I recommend that this transfer in the amount of \$20,000 be made to Non-Departmental - Civic and Cultural Activities.
