## THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That Regina V. K. Williams is designated to act as Acting City Manager during the periods of time in which Robert C. Bobb, City Manager, is absent, is incapacitated, or until the return to duty of the City Manager in accordance with the provisions of Section 5.07 of the Charter of the City of Richmond.

§ 2. That Sanford M. Groves is designated to act as Acting City Manager during the periods of time in which Robert C. Bobb, City Manager, is absent, is incapacitated, or until the return to duty of the City Manager, and Regina V. K. Williams is also absent from the City or incapacitated in accordance with the provisions of Section 5.07 of the Charter of the City of Richmond.

§ 3. That John F. Berry is designated to act as Acting City Manager during the periods of time in which Robert C. Bobb, City Manager, is absent, is incapacitated, or until the return to duty of the City Manager, and both Regina V. K. Williams and Sanford M. Groves are absent from the City or incapacitated, in accordance with the provisions of Section 5.07 of the Charter of the City of Richmond.

THE CITY OF RICHMOND HEREBY FURTHER ORDAINS:

That Ordinance No. 86-191-184, adopted August 11, 1986, as follows, be and is hereby repealed.

§ 2. That Regina V. K. Williams is designated to act as Acting City Manager during the periods of time in which Robert C. Bobb, City Manager, is absent, is incapacitated, or until the return to duty of the City Manager, and Daniel W. Allen is also absent from the City, in accordance with the provisions of Section 5.07 of the Charter of the City of Richmond.

This ordinance shall be in force and effect upon adoption.
