**Accessing the Meeting:**

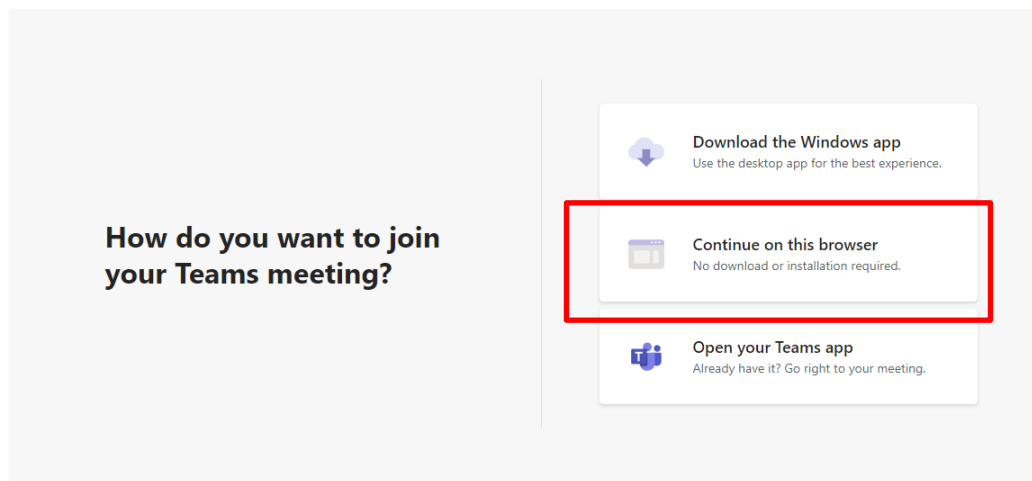
**1. Access the meeting by phone:**
