FY 2020 Comprehensive Annual Financial Report (CAFR)

Sheila White, Finance deputy director, formally presented Council with the Fiscal Year 2020 CAFR and acknowledged the outstanding contribution of key staff members from the Departments of Finance and Public Utilities responsible for the compilation of the report. Ms. White introduced the city's external audit partner, CliftonLarsonAllen (CLA), LLP's Greg Bussink, who provided a presentation regarding an overview of the CAFR, CLA's audit approach and results, technical update and new standards, and required governance communications. Mr. Bussink reported that the city received an unmodified (clean) opinion of its FY 2020 finances. A copy of the presentation and report has been filed.

Councilor Kristen Larson joined the meeting at 4:12 p.m.

Additional Proposed Change to Richmond Regional Planning District Commission (PlanRVA) Charter Agreement

Interim City Attorney Haskell Brown informed Council of an additional proposed change to PlanRVA's charter agreement and stated that the suggested amendment would adjust the number and type of member jurisdictions' voting seats by accounting for increases in population, thus aligning with current financial contribution assessments. Interim City Attorney Brown further stated that the immediate effect of the proposed change would allow the Counties of Henrico and Chesterfield an opportunity to increase their membership. Mr. Brown indicated that prior to PlanRVA finalizing changes to the charter agreement, he seeks to communicate the consensus of Council regarding their acceptance of the suggested amendment.

Councilor Ellen Robertson questioned the possible adverse effort of the additional proposed change to PlanRVA's charter agreement for the city.

Councilor Andreas Addison requested a comparison of other planning district commissions throughout the Commonwealth with similar regional transportation challenges.

President Cynthia Newbille asked that Council receive a copy of the recommended changes to the charter agreement as well as city administration's opinion regarding the inclusion of the proposed amendment.

Councilor Kristen Larson solicited Council's PlanRVA representatives to attend the upcoming planning district meeting to assess the sentiments of other member jurisdictions regarding the intended amendment.

After further discussion, there was no consensus of Council concerning the additional proposed change to PlanRVA's charter agreement.

Councilor Robertson inquired about information involving changes to the Central Virginia Transportation Authority.
