THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. The provisions of Article VIII of Chapter 9 of the Code of the City of Richmond, 1985, concerning sale of merchandise in the public parks of the City of Richmond and any other applicable provisions of law of the City of Richmond to the contrary notwithstanding, The Black Family Reunion Campaign 1987 may use Brown's Island for a festival event on Saturday, September 5, 1987, present live entertainment, playing of music or a concert, and allow the preparation and sale of food and the sale of souvenir items on Brown's Island on Saturday, September 5, 1987, between the hours of 10:00 a.m. to 8:00 p.m. The Black Family Reunion Campaign 1987 shall provide liability insurance, naming the City of Richmond as an additional insured in an

amount of not less than \$1,000,000 and shall comply with all other provisions of law and regulations of the City regarding use of public parks, traffic and crowd control bearing full cost of same, and tax and similar laws of the City for the sale of food and merchandise as a requisite for obtaining permission for such usage.

§ 2. This ordinance shall be in force and effect at 10:00 a.m. on Saturday, September 5, 1987, and shall continue in force until 8:00 p.m., on Saturday, September 5, 1987.
