[BZA 03-2026](#) An application of Family 610 Trust for a special exception from Sections 30-300, 30-410.1, 30-800.1, 30-800.2(a) & 30-800.4 of the zoning ordinance for a building permit to re-establish the nonconforming use rights to an adult care residence and construct an addition, porte cochere, elevator, ADA ramp, and site (parking area) improvements at 610 FOURQUREAN LANE (Tax Parcel Number N000-0906/018), located in an R-5 (Single-Family Residential) District. The proposed use is not permitted as the previous nonconforming use rights have expired and a nonconforming use shall not be extended, expanded, enlarged or moved to occupy a different or greater area of land, buildings or structures than was occupied by such use at the time it became nonconforming. For the purposes of the record it also requested that before addressing the Board you identify yourself and spell your name.
