#### Introduction of Legislation

1. An ordinance to amend Ord. No. 2022-104, adopted April 25, 2022, concerning the City's first tranche of the American Rescue Plan Act of 2021 funds related to the financing of the construction and preservation of single-family and multifamily dwellings.
2. An ordinance to authorize the Chief Administrative Officer to execute a Vehicle Lease Agreement between the City of Richmond and the Richmond Ambulance Authority to lease certain ambulances owned by the City.
3. An ordinance to amend the City's Zoning Ordinance for the purpose of amending the existing RP Research Park District concerning uses, yards, screening, parking and circulation of vehicles, height, signage, street side yards, emergency, transitional, and permanent supportive housing, and off-street parking requirements and creating usable open space and building facade fenestration requirements in the RP District.
4. An ordinance to amend the official zoning map for the purpose of rezoning certain properties in the area generally north of East Broad Street, south and west of Interstate 64/95, and east of North Third Street and to update Priority Street and Street-Oriented Commercial designations in the area.
