## **Diamond District Update**

Maritza Pechin, Planning and Development Review deputy director, provided Council with an update regarding the proposed Diamond District redevelopment, which included information regarding the process for requests for interest, additional information and offers, RFAI respondents, project goals, evaluation criteria and panel, and upcoming key dates. A copy of the presentation provided has been filed.

Councilor Andreas Addison inquired regarding the development of surrounding areas to the proposed Diamond District and asked city administration to maximize opportunities.

Vice President Ellen Robertson inquired regarding the cultivation of community benefit agreements for potential development projects and the city's role with promoting the Diamond District project once a vendor is selected.

Sharon Ebert, deputy chief administrative officer – Economic Development, was available to answer questions concerning the Diamond District project.

Councilor Stephanie Lynch questioned whether Council will be given an opportunity to weigh in on project incentives for the Diamond District proposal.

Councilor Kristen Nye inquired regarding a planned tour of the National Harbor and Potomac Yard development sites scheduled later in the week.

Ms. Pechin informed Council of her intent to meet with them individually to discuss the proposed request for offers pertaining to the Diamond District redevelopment.

Councilor Michael Jones expressed enthusiasm regarding the proposed development and challenged adjacent business owners to do more for their community.

Councilor Addison commented on a boilerplate approach for community benefit agreements.

Leonard Sledge, Economic Development director, provided a brief update regarding the One Casino + Resort redevelopment proposal scheduled for a second referendum in November.

## **Other Discussion**

Chief Administrative Officer Lincoln Saunders informed Council of proposed legislation scheduled to be introduced for expedited consideration later that evening at the Formal Session of Council, determining and directing the final disposition of the General A. P. Hill monument removed by the City to be donated to the Black History Museum and Cultural Center of Virginia, Inc., upon certain terms and conditions, and providing for the respectful disinterment from the site, the remains of General A. P. Hill.

After an inquiry regarding the expedited consideration of the proposed legislation, Mr. Saunders explained the intent would allow city administration to begin legal proceedings for the disposition of the monument as well as eliminate safety concerns at the intersection. However, Mr. Saunders stated expedited consideration is not essential.

Councilor Ann-Frances Lambert expressed appreciation for the expedited consideration of the proposed legislation and asked for her colleagues' support.

Councilor Katherine Jordan also expressed support for the proposed expedited consideration of the legislation and requested to be added as a co-patron.

Councilor Kristen Nye requested an update regarding the pay plan study report and efforts to reimagine Monument Avenue during a future meeting.
