# Introduction of Richmond Henrico Health District (RHHD) Director Dr. Elaine Perry

Ruth Morrison, RHHD policy director, introduced newly appointed Richmond Henrico Health District director, Dr. Elaine Perry to members of Council, who expressed her appreciated for the opportunity and her RHHD team.

Councilor Kristen Nye arrived at 4:15 p.m. and was seated.

President Cynthia Newbille welcomed and thanked Dr. Perry for her service and stated Council looked forward to working with her regarding public health matters.

# **New Handicapped Accessible Voting Machines Demonstration**

General Registrar Keith Balmer provided Council with a demonstration of the new handicapped accessible voting machines, Express Vote, which will be utilized only for in-person absentee voting. General Registrar Balmer explained VA Senate Bill 3 requires the reporting of absentee results by precinct, and the Express Vote machines will allow for compliance along with providing for the printing of on-demand ballots with unique ballot styles at election precincts. Mr. Balmer stated he will work to inform the public regarding the use of the Express Vote machines prior to the start of this year's early voting.

Councilwoman Reva Trammell voiced her uncertainty surrounding the new Express Vote machine and stated it was poor timing to implement their use since early voting starts September 23, 2022.

#### Virginia General Assembly 2023 Session Kickoff and 2022 Session Update

Ron Jordan, council lobbyist, Advantus Strategies (AS), presented Council with the final report regarding the Virginia General Assembly (GA) 2022 session, which included outcomes of city legislative program bills, impacts of the adopted state budget, Richmond Public Schools key funding drivers for the 2022-2024 biennial budget and adopted bills of interest. Mr. Jordan introduced new AS staffer, Government Relations Senior Director Kathy Burcher, who will be assisting Council with the city's legislative proposal for the GA 2023 session. # **Diamond District Update**

Maritza Pechin, Planning and Development Review deputy director, and Leonard Sledge, Economic Development director, provided Council with an update regarding the proposed Diamond District redevelopment, which included information regarding the project goals, evaluation panel, criteria and status, process for requests for interest, additional information and offers, RFAI respondents, typical financing tools and next steps. Ms. Pechin informed Council of a forthcoming announcement regarding the selection of the preferred development teams for the proposed Diamond District.
