Sherrill Hampton, Housing and Community Development Director, introduced RES. 2022-R023, and acknowledged that Greta Harris, President and CEO of the Better Housing Coalition, was present to respond to questions.

Member Michael Jones expressed his support of the proposed legislation.

#### **Public Hearing**

Sara Reichert, resident of Moss Side Avenue, spoke in support of ORD. 2022-105, and stated that the city had installed traffic mitigating strategies; however, the efforts have not deterred drivers from exceeding the posted speed limits.

Molly Brannan, resident of Moss Side Avenue, expressed concern regarding the safety of neighborhood residents, and recalled a number of traffic incidents she had witnessed over the years. Ms. Brannan informed the committee that a majority of the area's residents supported ORD. 2022-105.

Sharon Peterson, resident of Moss Side Avenue, spoke in support of ORD. 2022-105, and she described times she had witnessed drivers exceeding the posted speed limits and failing to stop at a stop sign.

Max Hepp-Buchanan, resident of Moss Side Avenue, spoke in support of ORD. 2022-105, and suggested that the proposed legislation be amended to specify the number of speed tables.

Ryan Klein, resident of Moss Side Avenue with wife Becca Klein, spoke in support of ORD. 2022-105, and stated that current traffic calming measures have had little impact on traffic and pedestrian safety. Mr. Klein commented that the fiscal impact to install the speed tables could never compare to saving a life.

Alex Warren, resident of Moss Side Avenue, spoke in support of ORD. 2022-105, and an amendment to specify the number of speed tables to be installed.

Emmett Corboy, resident of Moss Side Avenue, expressed concern regarding the safety of pedestrians and residents. Mr. Corboy urged the committee to support ORD. 2022-105.

Jessica Rexroat, resident of Moss Side Avenue, spoke in support of ORD. 2022-105, and recalled a number of drivers she witnessed exceeding the posted speed limits and failing to stop at a stop sign.

Citizens were provided an opportunity to offer comments in writing regarding pending legislation prior to the committee meeting. All written comments received by the Office of the City Clerk were provided to members of the committee and can be accessed below.

M. Khara, Department of Public Works Deputy Director/City Engineer, reported that the proposed request did not meet the Manual of Uniform Traffic Control Devices guidelines, and asked the committee to continue ORD. 2022-105 to its June 21 meeting, to allow city administration time to conduct a speed study and review crash data of the area, which will take approximately 45 days.

Member Michael Jones stated he supported the installation of speed tables to address concerns expressed by the area's residents, and he recalled similar traffic violations in the 9th Council District. Mr. Jones also stated that the city needed to develop a comprehensive plan to reduce traffic hazards citywide.

Mr. Khara stated that public education, implementation of policies and police enforcement were the best tools to reduce traffic violations. Mr. Khara explained that, if approved, DPW will conduct a traffic study to determine the number of speed tables to be installed.

Bobby Vincent, Department of Public Works Director, reported if supported by the city's traffic study, the speed tables will be installed in conjunction with the Moss Side Avenue FY 2023 pavement project, and that city administration will continue to work with the patron on viable options.

Chair Andreas Addison urged residents on Moss Side Avenue to solicit support from the Virginia General Assembly for a speed camera program in the city.

There were no further comments or discussions and Member Michael Jones moved to forward ORD. 2022-105 to Council with the recommendation to approve, which was seconded and unanimously approved.

The following resolution was considered:

5. <u>RES.</u> 2021-R086

To request that the Mayor propose, as part of his annual budget for Fiscal Year 2022-2023, the necessary amendments to the City Code and appropriations to establish a Department of Mobility and Multimodal Transportation.

Chair Andreas Addison advised the committee of his request to amend RES. 2021-R086 to reflect incorporation in the FY 2024 annual budget. Chair Addison stated the intent of the proposed legislation is to explore resources around pedestrian safety. Chair Addison encouraged city administration to become a member of the National Association of City Transportation Officials (NACTO).

M. Khara, Department of Public Works (DPW) Deputy Director/City Engineer, commented that goals included in RES. 2021-R086 are currently being executed under the umbrella of DPW.

Robert Steidel, Deputy Chief Administration Officer (DCAO) for Operations, expressed support of the proposed amendment which will allow city administration time to explore concepts to promote safer streets.
