I wanted to include my voice in support of the project at 3415A Floyd Avenue known as Crenshaw Mews. I attended the MDA meeting on Tuesday evening (11/30/21) and it appeared like a mob scene whipped up by the non-resident lawyer property owner. Many supporters appeared fearful of speaking up at the meeting. I understand some of the fears of the adjacent property owners who are residents and their NIMBY approach. We heard the standards - parking issues, stormwater issues, sewer issues, water issues, security issues, fire issues....But all of these have been addressed in the design and with the City.

We do need to increase density for those who are locked out of realistic access to public transportation and living close to their jobs. Every major city in our country, many that we aspire to be like, are moving this direction right now to find appropriate infill projects. This project is not intended to be high-end housing with elevators and penthouses like most of the recent infill projects, but moderate income rental properties for families and individuals. This property is even specifically identified on our own award-winning Richmond 300 Plan as a Carytown Enterprise Zone property (see attached). The project is also consistent with other alleyway structures in the Fan and Museum District in scale and stylistic context.
