PURPOSE: To authorize the Chief Administrative Officer to accept a \$25,000 grant awarded to the City of Richmond by the Virginia Department of Criminal Justice Services and to appropriate the grant funds received to the Fiscal Year 2021-2022 General Fund Budget by increasing estimated revenues and the amount appropriated to the Office of the Deputy Chief Administrative Officer for Human Services for the purpose of funding a comprehensive community assessment for the development of gun violence prevention and intervention services.

REASON: The City of Richmond is engaging in community-based efforts to address and reduce gun violence in the city in a way that is community-guided and community-centered. The \$25,000 grant award provided by the Virginia DCJS supports the city's efforts to assess and address community violence based upon the perspectives, experiences and input of residents directly impacted by the trauma of gun violence.

RECOMMENDATION: The City Administration recommends adoption.

BACKGROUND: Violence is a significant public health crisis in Richmond, Virginia. While violence affects citizens from all socioeconomic groups, the vast majority of violence in Richmond occurs in communities experiencing interdependent economic, educational, public health, transporta-

tion, housing, and public safety challenges and a cycle of intergenerational poverty. The City of Richmond, Virginia, is a mid-sized city with an outsized problem: intentional injury due to violence among its young people is disproportionate to its population and again on the rise. The historical and societal causes for this violence are multi-layered and complex, but the sheer numbers are straightforward and speak to the need for meaningful change.

In response to this public health crisis, the City of Richmond will work with community representatives to conduct a comprehensive Gun Violence Community assessment based on evidence-based, gun violence prevention and intervention models and practices. This assessment will be conducted over a period of three-four months and resulting data will be utilized to solidify a plan of action for implementing gun "interrupter" strategies, increasing access to positive opportunities forfamilies, and mapping community-based programs that provide prevention and intervention services and supports, including the identification of any corresponding policies that may have a direct impact on gun violence prevention. The assessment will include city-wide data collection using existing datasets from local agencies and organizations and a combination of self-administered surveys, focus groups and interviews. Ultimately, the results of a data review will be useful to conduct the follow:

- Identify perceptions of the problem.
- Identify level of direct engagement with impacted communities on problem-framing and solution identification.
- Identify hotspot areas, territory disputes, major arrests and releases, etc.
- Identify and support high risk individuals.
- Identify current programs, activities, policies that currently address the issue, including areas of strength and opportunities for improvement.
- Create a map of neighborhoods by incidents of violence and the availability of crisis-to-thriving resources.
- Develop a strategic plan for primary information-gathering via surveys, community focus groups and interviews.

Equity, inclusion and justice will be key principles in both the assessment and resulting plan of action. The assessment will center the voices, perceptions and experiences of those most disproportionately impacted by gun violence in Richmond—youth and young adults of low socio-economic status and their families. Ensuring an equity-centered approach also involves connecting to diverse stakeholders that focus on community impact and cultural competency in order to better understand the extent of the problem and its impact on disproportionately affected members of the community, its root causes and the needed programmatic, policy and cultural responses.

The community assessment will be funded by \$25,000 in outside contributions from a Virginia Department of Criminal Justice Services grant award.
