# Meeting Minutes - Final Public Safety Standing Committee

#### Call to Order

Chairwoman Reva Trammell called the meeting to order at 12:02 p.m., and presided.

## **Electronic Meeting Announcement**

# Citizen Speaker Guidelines

#### **Public Comment Period**

The committee held a moment of silence for the three Baltimore firefighters who died in the line of duty.

Keith Andes, International Association of Fire Fighters Local #995 (I.A.F.F. Local #995) union president, discussed the need for city leaders to support full funding for public safety officers. Mr. Andes noted the amount of overtime hours public safety officers were forced to work due to staffing shortages, and he indicated that interest groups representing public safety officers have not been given an opportunity to work with the city regarding pay plan proposals.

Chairwoman Reva Trammell requested that a discussion item be placed on the next meeting's agenda to discuss concerns expressed by public safety officers relative to the current pay scale, mandatory overtime and staffing shortages. Chairwoman Trammell asked the committee for its recommendations as to the best approach to address concerns.

Member Ellen Robertson suggested that the committee hold a work session with public safety representatives during a committee meeting.

Vice Chair Ann-Frances Lambert expressed support for a work session.

#### Presentation(s)

#### **Richmond City Sheriff's Office Update**

Richmond City Sheriff Antionette V. Irving provided responses to questions previously submitted by the committee regarding sheriff deputy retention and recruitment, inmate education, staff training and violence prevention within the Justice Center. Sheriff Irving presented information on internal programs offered at the city's Justice Center and state grant funding for 2021.

Sheriff Irving reported that inmates are provided resources to address their needs in the categories of mental health and education. Sheriff Irving stated that the department currently has 130 vacancies and the fiscal impact to fill half of those vacancies would be approximately \$500.000.00.

The committee asked questions relative to factors contributing to the increase in employee turnover, trends or behaviors to address in order to reduce incarceration rates, and staffing levels.

Member Ellen Robertson requested follow-up information regarding census data for incarcerated city residents.

#### Paper(s) for Consideration

#### The following ordinance was considered:

1. ORD. To amend ch. 27, art. V, div. 1 of the City Code by adding therein a new section 27-132, concerning the use of photo speed monitoring devices in

highway work zones and school crossings.

Victoria Pearson, Richmond Police Department (RPD) senior deputy department director, introduced ORD. 2021-371 and explained that the speed monitoring devices would be used for active work zones, and school crossing zones, two hours in the mornings and two hours in the evenings. Ms. Pearson stated that citations would be issued to vehicles driving in excess of 11 miles per hour of the posted speed limits for those zones.

The committee asked questions regarding the number of monitoring devices the city would acquire, determining factors in locations for the devices, and management of the program.

Captain Christopher Gleason, RPD Special Operations Division, reported that, initially, the program will begin with four (4) mobile monitoring devices; he stated that for school zones, devices could be installed based on requests by City Council or neighborhood complaints.

Captain Gleason further stated that state law restricts the use of the devices to active work and school crossing zones; however, some Council members have expressed interest in supporting legislation to request an amendment to the state code to allow placement of the devices in residential areas.

Mike Sawyer, Department of Public Works transportation engineer, responded to questions regarding the funding source for the program. Mr. Sawyer reported that the monitoring devices have proven to be effective and fines from the speed violations could provide the funding to sustain the program.

Member Ellen Robertson expressed concern about placing the monitoring devices in school zones based on neighborhood complaints.

Chief Gerald Smith stated that placement of the devices will be decided in a comprehensive manner to improve traffic safety citywide.

Member Ellen Robertson and Chairwoman Trammell asked to be added as co-patrons.
