Richmond Ambulance Authority

Richmond City Council, the governing legislative institution of Richmond, Virginia, in the United States of America, does hereby recognize, honor, and celebrate the Richmond Ambulance Authority as it commemorates its 30th Anniversary in our great city.

Established September 23, 1991, the Richmond Ambulance Authority is a unique quasi-governmental entity that operates independently of Richmond city government in providing emergency and nonemergency ambulance services, critical care transport, and a bike medic team.

Initially operated using an outsourced contracted company, since November 17, 2007, all Richmond Ambulance Authority personnel have been employed directly by the self-run entity that is governed by its 11member Richmond Ambulance Authority Board of Directors, which includes a member of Richmond City Council as well as the City of Richmond's Chief Administration Officer and Director of Finance.

Operating with an estimated \$20 million in annual revenues, of which approximately 75 percent comes from patient billings and 25 percent from a city subsidy, the Richmond Ambulance Authority responds to an estimated 50,000 emergency response calls a year.

Over its 30 years of existence, the Richmond Ambulance Authority has earned important Emergency Medical Service industry operator accreditations, which include one from the Commission on Accreditation of Ambulance Services for compliance with national emergency medical service standards of excellence, and one from the International Academies of Emergency Dispatch Accredited Center of Excellence.

Rhonda Michelle Harmon

Richmond City Council, the official governing body of Richmond, Virginia, in the United States of America, does hereby celebrate the life and legacy of Rhonda Michelle Harmon in remembrance of her passing on January 19, 2022.

Born and raised in Waco, Texas, Ms. Harmon accepted an appointment to the United States Military Academy at West Point in New York following graduation from high school in 1981 and was a trailblazing member of the fifth class after it began allowing women to enroll.

Following her graduation in 1985, commissioned Second Lt. Harmon served in the United States Army as Military Intelligence Officer and was stationed in Korea and Fort Hood, Texas.

Following her military service, Ms. Harmon was accepted to law school in 1990 and, in 1993, graduated first in her class from Baylor Law School in Waco, Texas. Following graduation from law school, Ms. Harmon accepted a public service judicial clerkship with The Honorable Samuel Johnson, Senior Judge of the United States of America Court of Appeals for the Fifth Circuit in Austin, Texas.

Moving to the Richmond area in 1995, Ms. Harmon joined a law firm and was part of a legal team that successfully that won an historic civil rights case on behalf of the nonprofit Housing Opportunities Made Equal (HOME) involving the discriminatory practice of redlining, which resulted in the largest verdict amount in their favor at that point in history.

Committed to her community, in 2020 Ms. Harmon was named the "Richmond Christmas Mother" as part of the nonprofit Richmond Christmas Mother Fund that provides financial backing for multiple charities throughout the Greater Richmond Region.
