## Richmond Redevelopment and Housing Authority (RRHA) Lease Evictions Update

Stacey Daniels-Fayson, RRHA interim chief executive officer, provided Council with an update regarding the Authority's efforts to proceed with lease enforcement. Ms. Daniels-Fayson presented a snapshot of income and monthly rent ranges of RRHA tenants, current outstanding ledger balances of all Authority properties and continued strategies to assist families in arrears.

Councilor Stephanie Lynch advocated for a possible rental debt forgiveness program.

## 1st Quarterly Report of American Rescue Plan Act (ARPA) Expenditures

Jason May, Budget and Strategic Planning director, presented Council with the first quarterly report of current and future ARPA expenditures.

Councilor Michael Jones requested a report of ARPA funded projects and stressed the need to utilize and/or provide opportunities for minority businesses.

Vice President Ellen Robertson expressed her support of Councilor Jones' request and asked that the report reflect the entirety of the approved APRA budget with delineated expenditures.

Councilor Andreas Addison stressed the importance of an investment in workforce development.

## Inclement Cold Weather Shelter and Planned Shelter Update

Sherrill Hampton, Housing and Community Development director, provided Council with an inclement weather shelter and planned shelter update, which included a 4th quarter report and up-to-date analysis of shelter utilization demographic information.

Jay Brown, Commonwealth Catholic Charities chief executive officer, was available to answer to questions regarding the operation of the temporary inclement weather shelter, and updated Council regarding construction of the Oliver Hill Way planned shelter scheduled to open October, 2022.

Councilor Katherine Jordan inquired regarding potential overhead construction cost of the planned facility.

Vice President Ellen Robertson inquired concerning the civic engagement surrounding the planned shelter and expressed her willingness to host a community meeting.

Councilor Katherine Jordan exited the meeting at 5:11 p.m.

Councilor Michael Jones expressed his appreciation of Commonwealth Catholics Charities' and city administration's outreach efforts.

Councilor Andreas Addison requested the partnering with the Greater Richmond Transit Company to ensure adequate public transportation accessibility near the planned shelter. Mr. Addison also requested Council be provided a cost estimate for potential construction needed to complete the planned shelter during an upcoming budget deliberation.
