Item Title: Resolution of Intent to Amend the Development Review Process

Director Kevin Vonck provided the staff presentation.

Commissioner Andreas Addison asked if the development community could be engaged early in the process.

Director Kevin Vonck explained that the new Deputy Director will be involved with helping engage stakeholders. He said that staff hosted one or two preliminary meetings with some of the development community and there has also been engagement with HBAR.

Commissioner Vivek Murthy commended the Director on the work and acknowledged that other localities have struggled with increased construction activity and limited resources as well. He asked if the red boxes from the presentation were something that is in the current operating budget and what the timeline is to fill those positions.

Director Kevin Vonck explained that the positions are all funded and the boxes were simply to show what is in line with development review. He noted that the only vacant position is his former position as Deputy Director and that an offer has been extended to fill that position. He thanked CAO Lincoln Saunders for ensuring that the department has the resources in place to make the process happen.

Commissioner Elizabeth Greenfield thanked Director Kevin Vonck, CAO Lincoln Saunders and staff for moving this process forward and engaging with the development community.

Commissioner Lincoln Saunders acknowledged the work and effort of Director Kevin Vonck, Jeff Gray and the MMR team.

Chairman Rodney Poole thanked Director Vonck and staff. He asked Director Vonck if there was any item he learned the most from in the preparation for the new development review process. Director Vonck stated that it is critical that those who attend the meetings have the scope of authority to make a decision.

Item Title: RESOLUTION OF INTENT TO AMEND THE OFFICIAL ZONING MAP FOR THE PURPOSE OF REZONING CERTAIN PROPERTIES IN THE AREA GENERALLY NORTH OF EAST BROAD STREET, SOUTH AND WEST OF INTERSTATE 64/95, AND EAST OF NORTH THIRD STREET IN ACCORDANCE WITH THE RICHMOND 300 MASTER PLAN.

Brian Mercer provided the staff presentation.

Commissioner Burt Pinnock expressed some concern over unrestricted height within the downtown area.

Brian Mercer noted that the City Center plan did call for unrestricted height in this area.

Commissioner Pinnock explained that environmental impacts such as light and wind should be considered, particularly where there are narrow streets.

Brian Mercer said that staff is using Sketchup to see what can be accomplished with and without an inclined plane.

Director Kevin Vonck added that staff has been discussing the inclined plane internally and whether or not it would make sense to eliminate it in the B-4 District or create a new district that would apply solely to the downtown area.

Commissioners Vivek Murthy and Andreas Addison expressed support for allowing more height in the City Center area.

Chairman Rodney Poole urged staff to engage a diverse group of the development and local community to ensure that the proposed zoning changes will meet the needs of all parties.

No citizens spoke during the public hearing.

Director Kevin Vonck acknowledged that this rezoning is a priority in order to position the City competitively.
