Citizen Comment

CD.2022.097 March 14, 2022 Citizen Comment Period Speakers List

Demetrios C. Axarlis addressed Council and stated his concerns with the city moving forward with speed camera enforcement. Mr. Axarlis noted that he was most concerned that the city would become reliant on speed cameras to increase city revenue. Mr. Axarlis also requested that Council respect the voice of residents by accepting the results of a previous referendum regarding the establishment of a resort casino in the city. Mr. Axarlis further stated his concerns with the potential of the city implementing a land use tax.

Bob Downs addressed Council and stated his suggestions regarding the city's implementation of a potential civilian review board. Mr. Downs informed Council of his disagreement with civilian review board recommendations raised by consultant Dr. William Pelfrey, Jr. Mr. Downs also stated that any civilian review board must be independent from the Richmond Police Department.

Phil Shepard, Service Employees International Union (SEIU) member, addressed Council and stated that city employees should have one collective bargaining unit for representation. Mr. Shepard also stated that city employees should be allowed to bargain regarding all working conditions and be permitted to discuss union matters on the job site.

Mr. D'Archangel addressed Council and stated his support for collective bargaining. Mr. D'Archangel also spoke in support of a city-wide collective bargaining unit that represented all city employees.
