THE CITY OF RICHMOND HEREBY ORDAINS:


§ 1. That those portions of Resolution No. 98-R102-107, adopted July 13, 1998, as amended by Resolution No. 2000-R111-109, adopted July 24, 2000, Resolution No. 2003-R132-123, adopted July 14, 2003, Resolution No. 2003-R155-141, adopted September 8, 2003, and Resolution No. 2004-R125-131, adopted June 28, 2004, concerning the creation, composition, terms of office, duties, and functions of the Slave Trail Commission, shall be and are hereby repealed.

§ 2. That (i) the Slave Trail Commission is hereby abolished, and (ii) the terms of the members of the Slave Trail Commission be and are hereby terminated.

ORDINANCE/RESOLUTION SUMMARY

Patron request that legislation be drafted for Council's consideration terminating the existence of the City's Slave Trail Commission.

BACKGROUND

The Slave Trail Commission was established pursuant Res No. 98-R102-107, adopted July 13, 1998, and amended, most recently, pursuant Res No. 2004-R125-131, adopted June 28, 2004. The Slave Trail Commission was created to establish a national educational resource that will contribute to the healing of Richmond's racial history.

The Commission has completed its initial work; it is now necessary to repeal the legislation establishing it. The Council is working to replace the Commission and refine its work with the Shockoe Alliance Coalition and the National Slavery Foundation Museum.
