### Call to Order

Council President Cynthia Newbille called the meeting to order at 6:05 p.m., and presided.

Invocation was offered by Pastor Eric W. Carroll of Second Branch Baptist Church, 12217 2nd Branch Road, Chesterfield, Virginia.

Members of Council and the audience recited the Pledge of Allegiance.

### Chamber Emergency Evacuation Plan Announcement and Citizen Speaker Guidelines

Upon the President's request, Deputy City Clerk RJ Warren provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency along with citizen speaker guidelines.

Council observed a moment of silence acknowledging victims of recent gun violence in the city and the victims of a vehicle accident involving the Richmond Police Department.

Council President Cynthia Newbille, on behalf of City Council, recognized Richmond Public Safety Emergency 9-1-1 Telecommunicators Week, and she provided additional comments regarding Council's appreciation of Richmond Department of Emergency Communications' Richmond 9-1-1 Emergency Communications Center staff.

### **Citizen Comment**

[CD.2022.158](#) April 11, 2022 Citizen Comment Period Speakers List

John Owens addressed Council and advocated for the creation of a national slavery museum at Main Street Station. Mr. Owens stated that the central location and the available space of Main Street Station was ideal for such a museum. Mr. Owens also recommended that phase two of a national slavery museum take place at the location of the James Monroe building.

Melvin Jones requested that Council introduce a resolution to acknowledge the birthday of Maggie Walker. Mr. Jones also requested that Richmond lead a summit of surrounding localities to address gun violence. Mr. Jones also stated his concerns that the city should better inform citizens trying to pay utility bills at the East District Center that bills can only be paid on the 1st and 15th of each month.

Richard Sinsabaugh, Friends of Bryan Park President, addressed Council and stated his concerns with unleashed dogs in Bryan Park. Mr. Sinsabaugh also stated that unleashed dogs defecate on soccer fields and destroy plant life in the park. Mr. Sinsabaugh further stated it was dangerous for individuals to be in the park around unleashed dogs.

*Councilor Stephanie Lynch arrived at 6:23 p.m., and was seated.*

Edward Jewett, Richmond City Circuit Court Clerk, addressed Council and stated his appreciation for Council's adoption of ORD. 2022-086, which provided bonuses to city employees of constitutional officers. Mr. Jewett informed Council of the work the employees of the Richmond City Circuit Court Clerk's Office accomplished throughout the COVID-19 pandemic.

*President Cynthia Newbille and Councilwoman Reva Trammell stated their appreciation for the comments of Mr. Jewett and the work of his staff.*

Austin Koch, Friends of Church Hill Dog Park Member, addressed Council and stated his concerns with unleashed dogs in city parks. Mr. Koch informed Council that unleashed dogs create dangerous and stressful situations when he is walking with his leashed dogs.

## Public Hearing

Benjamin Andrews, on behalf of Grace Properties, spoke in opposition of ORD. 2022-095, and stated that the ordinance lacked clarity regarding certain aspects of the proposed development. Mr. Andrews also stated that parking was a major concern of Grace Properties. Mr. Andrews further stated concerns with the proposed size of the development.

Karen O'Brien, Caritas Chief Operating Officer, spoke in support of ORD. 2022-099, and stated it would provide federal stimulus funding for the repurposing of an emergency men's shelter.

Anita Bennett, Daily Planet Health Services Chief Executive Officer, spoke in support of ORD. 2022-099, and stated that the ordinance would transfer federal funding to Daily Planet Health Services to be used for providing health services to individuals experiencing homelessness.

*Councilor Katherine Jordan provided additional information regarding ORD. 2022-095, and stated that the local neighborhood association approved of the development.*

Preston Lloyd, Williams Mullen Partner, on behalf of ORD. 2022-095 applicant, stated that the majority of the proposed development was allowed by right, and that the special use permit was only to request relief from a 20 foot setback requirement. Mr. Lloyd also stated that the proposed ordinance was recommended for approval by the Planning Commission.

*President Cynthia Newbille stated her appreciation for the work and services provided by Caritas and the Daily Planet.*

## **Public Hearing**

**[CD.2022.159](#)** April 11, 2022 Budget Public Hearing Speakers List

It was the consensus of Council to allow individuals two minutes to provide public comment regarding budget related papers.

Melvin Jones referenced ORD. 2022-069, and requested that Council consider providing a cost of living adjustment for retired city employees.

Josh Stutz, Friends of the James River Park Executive Director, spoke in support of the proposed funding for a Park Ranger Program. Mr. Stutz stated that a Park Ranger Program would address many of the issues that residents experience at city parks, such as off leashed dogs, graffiti and safety concerns.

Vernon Knapp, Friends of Bandy Field Nature Park Representative, referenced prior action taken by Council to approve additional animal control officers to address unleashed dogs in city parks, but noted that the staff positions were frozen due to the COVID-19 pandemic. Mr. Knapp requested that Council fund the two positions to help address the unleashed dog problem in city parks. Mr. Knapp also spoke in support of the proposed Park Ranger Program.

*A copy of the material provided has been filed.*

Ansley Perkins addressed funding for Richmond Public Schools (RPS) and stated that teachers should not have to rely on donations to provide a sufficient learning environment for students. Ms. Perkins also stated that capital improvements were greatly needed for RPS facilities.

Bill Muth addressed Council and requested that the proposed Fiscal Year 2023 (FY23) budget reflect the climate emergency Council declared when it adopted RES. 2021-R049 on September 13, 2021. Mr. Muth stated that delays to take action to address the climate emergency, would have severe impact on the planet.

Kirk Roberts, Richmond Ambulance Authority (RAA) Board Member, requested that Council fund the RAA appropriately to ensure that RAA can provide residents with care and services. Mr. Roberts also stated that additional funding was necessary to address rising costs and staffing shortages.

Kevin Cianfarini stated his appreciation for Council adopting RES. 2021-R049, and he requested that Council use the FY23 budget to address climate control within city residencies. Mr. Cianfarini also stated that the city should refrain from burning natural gas, and instead transition to the use of electrified heat pumps.

Christina Gunter, Lighthouse Labs Director of Strategic Partnerships, requested a \$250,000.00 budget amendment to provide Lighthouse Labs with funding to continue its work providing resources and assistance to local founders in the city. Founders Philip Deng, Grantable SaaS Cofounder and Chief Executive Officer (CEO), and Nancy Brown, Bookclubz Cofounder and Chief Revenue Officer (CRO), were present and provided Council with information regarding the assistance they received from Lighthouse Labs.

Captain William T. Spindle III, Richmond Fire Deputy Fire Marshal, Brothers and Sisters Combined Professional Firefighters, Inc. President, spoke in support of ORD. 2022-069 and stated that the ordinance would ensure that the city's public safety employees would be properly compensated.

Daniel Klein addressed Council regarding the issue of urban forestry and trees. Mr. Klein stated that the city needed to employ an urban forester, properly staff the urban forestry division, reestablish an urban forestry commission, create a urban forestry master plan, and adopt a new tree ordinance.

Bill Pantele, Richmond Coalition of Police (RCOP) Representative, spoke in support of ORD. 2022-069, and stated that the ordinance addressed issues that RCOP raised regarding the city's public safety officer pay plan. Mr. Pantele also requested a budget amendment to provide initial funding for the potential implementation of collective bargaining.

Charles Gerena, Sierra Club Virginia Chapter Member, stated he believed city owned vehicles should consist of electric vehicles rather than gas-powered vehicles. Mr. Gerena also stated that the city needed to provide more information on a timeline for when the city would transition to an all-electric vehicle fleet.

Leighton Powell, Parks and Recreation Advisory Board Chair, spoke in support of proposed funding for the Department of Parks, Recreation and Community Facilities and requested that Council adopt ORD. 2022-061.

Kidest Gebre, Virginia Interfaith Power and Light Organizing Coordinator and Energy Campaign Lead, stated that the city could do more to address climate justice, and that climate change should be indicated as a priority in the city's FY23 budget. Ms. Gebre also stated that the city should refrain from using natural gas and transition to electric energy.

Eric Shilts, Sierra Club Member, stated his concerns that Richmond Gas Works was not overseen by a public board or commission. Mr. Shilts also stated his concerns that Richmond Gas Works was using city funds to create long-term infrastructure that would exceed the proposed timeline for producing zero carbon emissions in the city. Mr. Shilts further stated the city should reallocate funding to increase environment friendly practices.

Tess Dixon, Friends of Chimborazo Playground Member, requested that Council approve the Park Ranger Program proposed in the FY23 budget and fund two additional animal control officers. Ms. Dixon stated her concerns with unleashed dogs in city parks and playgrounds, and she also stated that Council could take action to remedy the issue.

Sarah Weisiger stated that Richmond Gas Works needed public oversight by a public board or commission. Ms. Weisiger also stated that the oversight board would help review maintenance work and gas line extension to ensure that the transition away from gas continues.

Dr. Richard Sebastian, RVAgreen 2050 Community Working Group Member, provided Council with his experience volunteering for a heat study in the city. Dr. Sabastian stated that he observed that undeserved areas with larges amounts of concrete and limited tree cover were much hotter than other parts of the city. Dr. Sabastian also stated that the heat issue would get worse, because the city's proposed FY23 budget did not adequately address the climate emergency.

McKenna Dunbar, Ecological Justice Initiative Founder and President, MOCOKONO Chief Executive Officer, University of Richmond Business Student, Sierra Club Virginia Chapter Building Electrification Lead, stated that she worked to lead efforts for public schools and new construction to achieve net-zero emissions throughout the state. Ms. Dunbar also stated that the city could be a leader in the transition to an emission free state through action in the city's budget.

Barry O'Keefe stated his appreciation for Council declaring a climate emergency in the city. Mr. O'Keefe also stated that he was concerned with the proposed FY23 budget, because he did not believe it did enough to address the climate emergency that Council declared.

Lee Ann Williams stated that there was an urgency for the city to take action to address the climate emergency in the city. Ms. Williams also stated that the city needed to transition to electric energy and promote and advance climate justice.

Elle De La Cancela, Chesapeake Climate Action Network Central Virginia Organizer, stated that the FY23 budget did not adequately address climate readiness as recommended in the Richmond 300 Master Plan. Ms. De La Cancela also stated that the proposed FY23 budget did not promote mass transit enough, and that the city should allocate money to mass transit instead of parking lot maintenance.

Sheri Shannon, Southside ReLEAF Cofounder, stated that the FY23 budget should do more to address the health and wellbeing of the city's Southside residents. Ms. Shannon also stated that the city ranked 3rd in the nation for most asthma related deaths. Ms. Shannon requested that Council amend the budget to prioritize climate justice.

Christiane Riederer, on behalf of Susan Miller, MD, Virginia Commission for Climate Action Member, stated it was imperative that the city adopt a budget that reflects the climate emergency declared by Council. Ms. Riederer also stated that gas emissions needed to be eliminated and that the city needed to transition from gas-powered equipment to electrical.

Danielle Geronimo, Richmond Ambulance Authority (RAA) Paramedic Captain and Field Operation Supervisor, stated that RAA employees were the first line of assistance for many city residents in need of medical assistance. Ms. Geronimo also stated that the work of a first responder was very demanding on the mental state of RAA paramedic employees. Ms. Geronimo further stated that staffing shortages were creating additional issues for employees, and she requested that the city increase the financial support for RAA.

Garrett Trehune, RRA Employee, stated that requested funding for the RAA was necessary to ensure adequate staffing. Mr. Trehune also stated adequate staffing would cut down on required overtime and provide current employees with enough time away from the job to recharge before returning to work.

Jessica Cooper, University of Richmond School of Law Student, 500-Year Forest Foundation Legal Intern, requested that the city increase investment into environmental wellness. Ms. Cooper also requested that the city reinstate an urban forestry commission, establish a city urban forester employee, create an urban forestry master plan, and improve the city's tree plan.

Allan-Charles Chipman stated that the FY23 budget needed to direct funding to address the climate emergency in the city.

Daryl Downing spoke to the benefits of owning electric vehicles. Mr. Downing requested that the FY23 budget prioritize the purchase of electric vehicles and avoid adding new gas-powered vehicles to the city's fleet.

Joe Brancoli, Serra Club Falls of the James Group Chair, stated his appreciation for Council declaring a climate emergency in the city, and he requested that Council take direct action to address the emergency through the city's FY23 budget.

*Councilwoman Reva Trammell stated her appreciation for the RAA, and she requested that Council work to provide the RAA with adequate funding. Councilwoman Trammell also stated that Council needed to review how to fund affordable housing initiatives in the city.*

*Councilor Andreas Addison stated that Council needed to examine a comprehensive revenue strategy.*

*Councilor Katherine Jordan stated the FY23 budget required more progress to address environmental issues raised during the public hearing.*

*Councilor Stephane Lynch stated that she would support FY23 budget amendments proposed by Councilor Jordan to address environmental issues in the city.*

*President Cynthia Newbille stated that Council was committed to review ways to address the climate emergency through the FY23 budget.*
