Project Description	<p>Alice Fitz Community Garden</p> <p>The vision for this project is an art installation that enhances the functionality and aesthetic impact of this community garden. The objective is to commission a work that simultaneously addresses a pressing infrastructure need for the gardener while also promoting the City’s commitment to public art.</p> <p>The recommended project concept submitted by Ellanor Dahlgren will have a primary role as a shelter, rain catchment and storage for the garden. The shed/storage design is spacious (8’x10’) and will have room for shelves and racks for tools.</p> <p>The shelter will be a six foot overhang extending from the shed supported by wooden beams (total 6’x10’ space). There are three benches within, enough to comfortably seat a gathering of about six people. The shelter will be open air with “walls” on either side, made up of floating shadow boxes with negative space between. The boxes will be filled with objects, writing and photographs displaying the narrative of the community. Placed among the boxes will be a little free food pantry and seed library. The extended roof of the shelter will serve as water catchment using a gutter on the longer side of the roof that feeds into a water cube.</p> <p>The theme tying the design together aesthetically is memory and community narrative through object assemblage, imagery and written statements that will result from an extensive community engagement process.</p>
