
NOW, THEREFORE,

**ORDINANCE/RESOLUTION SUMMARY**

The patron request is to amend Ord. 2021-40, adopted May 24, 2021, which adopted the Fiscal Year 2021-2022 General Fund Budget to change the uses and allocation of the Council District Funds for the Third District and amends the 3<sup>rd</sup> District FY22 Anticipated Council District expense list.

**BACKGROUND**

The purpose of this amendment is to comply with requirements of Va. Code Section 15.2-2503, which requires that a locality's budget stipulate how local governing body discretionary funds will be used. This Section allows individual members of the governing body to propose amendments during the fiscal year to change the uses and allocation of those discretionary funds.

The Third District FY22 Anticipated District Expense List in the current budget ordinance, adopted May 24, 2021, does not specifically include a category for the Council Member to

be reimbursed for mileage expenditures using Council District Funds. The purpose of this proposal is to allow clear authority to make such expenditures by including the category, Mileage, to allow for reimbursement for personal miles attributable to district work.
