
THE CITY OF RICHMOND HEREBY ORDAINS:

#### ORDINANCE/RESOLUTION SUMMARY

The patron request is to amend Ord. 2021-40, adopted May 24, 2021, which adopted the Fiscal Year 2021-2022 General Fund Budget to change the uses and allocation of the Council District Funds for the Fifth District.

#### BACKGROUND

The purpose of this amendment is to comply with requirements of Va. Code Section 15.2-2503, which requires that a locality's budget stipulate how local governing body discretionary funds will be used. This Section allows individual members of the governing body to propose amendments during the fiscal year to change the uses and allocation of those discretionary funds.

The patron request is to amend Ord. 2021-40, adopted May 24, 2021, which adopted the Fiscal Year 2021-2022 General Fund Budget to change the uses and allocation of the Council District Funds for the Fifth District and amends the 5<sup>th</sup> District FY22 Anticipated

Council District expense list to amend the funding allocations to the categories as indicated on the Fifth District FY22 Anticipated Expense List. See Attached document.

The Fifth District FY22 Anticipated District Expense List category amounts in the current budget ordinance, adopted May 24, 2021 should be changed to reflect adjustments in the categories, as required by Va. Code Section 15.2-2503, for new district initiatives in FY22. The purpose of this proposal is to allow clear authority to make such expenditures by amending the Fifth Council District FY22 Anticipated Expense List.

The expected date of introduction is May 9, 2022.
