#### THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That Ordinance No. 2021-042, adopted May 24, 2021, which (i) accepted a program of proposed Capital Improvement Projects for the fiscal year commencing July 1, 2021,

and ending June 30, 2022, and the four fiscal years thereafter, (ii) adopted a Capital Budget for the fiscal year commencing July 1, 2021, and ending June 30, 2022, and (iii) determined a means of financing the same, be and is hereby amended and reordained by modifying the purpose of the Heritage Center / Lumpkin's Jail (Devil's Half Acre) project in the Economic and Community Development category to provide that the scope of such project includes the planning, design and implementation of the memorialization of the property known as 1305 North 5<sup>th</sup> Street due to the property's historical significance associated with its use as the Burial Grounds for Free People of Colour and Slaves, and the relocation, stabilization, renovation, and interpretation of the Winfree Cottage, the home of an enslaved woman.

PURPOSE: To amend Ordinance No. 2021-042, adopted May 24, 2021 (which accepted a program of proposed Capital Improvement Projects for the fiscal year commencing July 1, 2021 and ending June 30, 2022 and the four years thereafter, adopted a Capital Budget for the fiscal year commencing July 1, 2021 and ending June 30, 2022, and determined a means for financing the same), to modify the Heritage Center/Lumpkin's Jail (Devil's Half Acre) project in the Economic & Community Development Category to provide that such project includes the design and construction of a Pavilion/Museum at the Lumpkin's Jail/Devil's Half Acre site; the design of and improvements to the Richmond Slave Trail and Trail Head at Ancarrow's Landing; the extension of the Slave Trail to 1305 North 5<sup>th</sup> Street; the acquisition of the property at 1305 North 5<sup>th</sup> Street which has historical significance associated with its use as the Shockoe Hill African Burying Ground (Burial Grounds for Free People of Colour and Slaves); planning, design and implementation of the memorialization of 1305 North 5<sup>th</sup> Street; the relocation, stabilization,

renovation, and interpretation of the Winfree Cottage; and the planning activities for Shockoe Bottom and the proposed Heritage Campus.

**REASON:** An ordinance is necessary to amend the Capital Budget in order to provide that the Heritage Center/Lumpkin's Jail (Devil's Half Acre) project includes, and the funding appropriated for such project may be utilized for, such purposes listed above.

**RECOMMENDATION:** The City Administration recommends approval.

BACKGROUND: The general purpose of these funds is to honor the history of enslaved Africans in the City of Richmond. Prior to 2016, the Heritage Center/Lumpkin's Jail/Devil's Half Acre requests included funds for the Slave Trail. The requested clarification of funding purposes is in keeping with the past uses of these funds. The City of Richmond acquired the Shockoe Hill African Burying Ground (Burial Ground for Free Persons of Colour and Slaves) at tax sale in 2021.

Thus, this amendment is to allow funds for planning, design and implementation of the memorialization of the Shockoe Hill African Burying Ground which is of critical importance. The property, located at 1305 North 5th Street (N0000233006), was acquired by the City on April 16, 2021. This property was used as the burial site for Richmond's black population from 1816 to 1879 and it is believed that as many as 21,000 souls may have been buried in this cemetery. The property has been extensively desecrated over the years by the construction of roads, railroads, highways, and municipal buildings. It is also from this site that many of the remains found in the VCU well originated. Today, a billboard and the shell of a small gas station (vacant for many years) stand on the property, which in no measure resembles a cemetery or sacred space. This amendment is to allow the use of \$500,000 of these funds to begin the planning, design, and implementation of the memorialization of this significant property. This amendment will also allow the use of \$500,000 for the relocation, stabilization, renovation, and interpretation of the Winfree Cottage. The Winfree Cottage, the former home of Emily Winfree, an enslaved woman, was moved to Shockoe in 2002 to save it from demolition. The two-room cottage has sat on a trailer since then and is in need of a permanent location where it can be properly interpreted and tell the remarkable story of resilience and survival embodied in the life of Emily Winfree. A permanent location in the Manchester area, where the cottage originally stood has been tentatively identified.
