Ms. Ellalee Fountain Flowers (November 16, 1923 - May 15, 2022)

Richmond City Council, the governing legislative institution of Richmond, Virginia, in the United States of America, does hereby celebrate the life, works, service, and legacy of Ms. Ellalee Fountain Flowers in remembrance of her passing on May 17, 2022.

Born in Richmond, Virginia on November 16, 1923 in the historic Jackson Ward Neighborhood, Ms. Ellalee Fountain Flowers graduated at the top of her class from Richmond Public Schools Armstrong High School and went on to earn her Bachelor of Business Administration from Virginia State University and Master of Education from Columbia University.

Known throughout her life for her dedication, commitment, and advocacy on behalf of education and community service, Ms. Flowers taught business courses from 1945 to 1979 at Richmond Public Schools Maggie L. Walker High School and retired as head of its Business Department. Ms. Flowers also taught night school for adult and elementary school aged students.

Following her retirement, Ms. Flowers served as a faculty member of the Virginia Union University Sydney Lewis School of Business, from 1979 to 1987.

As further testament to her commitment, Ms. Flowers was an active member of Delta Sigma Theta Sorority, Inc., which included 80-years of collegiate and alumni community service, leadership, and ongoing commitment to scholarship, public service, and sisterhood, during which time she served as Chair of the Richmond Alumni Chapter's Habitat for Humanity and Political Awareness Committees. Ms. Flowers was also a lifelong member of the NAACP, serving as Secretary for the Richmond Chapter.
