Reports from City Administration, Council Staff and Other Parties

Preliminary Quarterly Report of American Rescue Plan Act (ARPA) Expenditures

Jason May, Budget and Strategic Planning Director, provided a status update on ARPA project.

Member Ann-Frances Lambert requested a list of locations for the facade and city beautification project, and information on the six projects awarded funding through the Health Equity Trust Fund project. Member Lambert also requested information regarding the lead line replacement project included in the report.

Member Katherine Jordan also requested additional information on the facade and city beautification project.

Vice Chair Ellen Robertson requested information on timelines, locations and performance measurements for each of the projects.

Mr. May advised the committee that the budget allocations for each project will be included in a comprehensive report to Council, due at the end of July.

Chair Cynthia Newbille inquired about the Richmond City Health District's public nomination process for community based projects to receive funding through the Health Equity Fund, which ends July 28, 2022.

Member Michael Jones inquired about the city's ability to reallocate ARPA funds from completed projects to other projects authorized under ARPA.

Reports of Standing Committees

There were no reports.

Consideration of Appointments to Boards, Commissions and Similar Entities

There were no appointment/reappointment items for consideration.

Paper(s) for Consideration

The following ordinance was considered:

ORD. To amend ch. 2, art. VI of the City Code by adding therein a new div. 6,

2022-220 consisting of §§ 2-1301.1 - 2-1301.20, concerning collective

bargaining, for the purpose of providing for collective bargaining with

certain City employees.

Lincoln Saunders, Chief Administrative Officer, stated that city administration was willing to continue working with the patrons to collaborate on the collective bargaining legislation.

Cynthia Hudson, Sands Anderson Counsel, was present to respond to questions.

Chair Cynthia Newbille announced that the ORD. 2022-220 will be amended, and that Council anticipates consideration of the amended legislation at its Formal Meeting on July 25, 2022.

Public Hearing

Ben Himmelfarb, employee with the Richmond Public Library and member of the Service Employees International Union (SEIU), asked that city workers be included in the creation of a collective bargaining ordinance.

Phil Shepard, employee with the Richmond Public Library and member of SEIU, requested that amendments proposed by SEIU be incorporated in ORD. 2022-220.

Maurice Black, city worker, stated that employee wages were not sufficient and that collective bargaining would afford employees the opportunity to negotiate competitive wages.

Bill Pantele, Richmond Coalition of Police representative, stated that the city's adoption of collective bargaining allowances would help stabilize the city's workforce. Mr. Pantele also stated that future agreements related to collective bargaining were still needed, but the proposed legislation was a great start in the right direction.

Keith Andes, International Association of Fire Fighters (IAFF) Local 995 President, spoke in support of collective bargaining for city workers, and stated that some of his concerns regarding the health and safety of the city's fire fighters could be addressed through collective bargaining.

Member Reva Trammell discussed her intentions to amend ORD. 2022-220 at a Special Council meeting prior to the July 25, 2022 Formal Meeting of Council.

Member Stephanie Lynch expressed her support of forwarding ORD. 2022-220 to Council with no recommendation to allow time for stakeholders to discuss components of the proposed collective bargaining policy.

Vice Chair Ellen Robertson addressed a need for Council to hold a work session to evaluate all of the collective bargaining legislation.

Member Michael Jones stated his support of collective bargaining for all city employees, and he emphasized a need for Council to support further economic development projects to support the fiscal impacts associated with collective bargaining.

There were no further comments or discussions and Member Stephanie Lynch moved to forward ORD. 2022-220 to Council with no recommendation, which was seconded and unanimously approved.

There were no discussion items.

At 6:29 p.m., Member Michael Jones moved that the Organizational Development Standing Committee hold a closed meeting pursuant to subdivision (A)(1) of section 2.2-3711 of the Virginia Freedom of Information Act to (i) discuss, consider, and interview a prospective candidate for employment as City Attorney and (ii) discuss salary increases for the City Assessor, the City Auditor, the City Clerk, and the Inspector General, and pursuant to subdivision (A)(7) of section 2.2-3711 of the Virginia Freedom of Information Act to receive a briefing from the City Attorney pertaining to actual litigation regarding monument removal and to consult with the Interim City Attorney pertaining to probable litigation regarding a proposed development project in the city where such briefing and consultation in open meeting would adversely affect the City's negotiating or litigating posture.

The motion was seconded and approved: Ayes 8, Addison, Jordan, Lambert, Lynch, Trammell, Jones, Robertson, Newbille.

Member Andreas Addison motioned to exit closed session. The motion was seconded and approved: Ayes 7, Addison, Lambert, Lynch, Trammell, Jones, Robertson, Newbille. Noes None. Jordan was excused.

Members reconvened in open session at 8:18 p.m.
