I have lived in the museum district for 12 years on the 3100 block of Stuart Ave. During that time I have watched this area become much more stable with people moving in and renovating homes which shows appreciation for living in a historic city with many conveniences. I myself have planned on remaining in this area for many more years. But after hearing about Saint Gertrude being turned into apartments I am now starting to rethink my future in the museum district. I strongly feel this is a poor use of that property not only in adding more population into a small area but also a transient population with no strong ties to the area. There is already an abundance of apartments on these blocks which makes it very hard to park and with more people it will become even more congested not only with traffic but also parking. I am aware that there is parking on the property but that would only account for one space per tenant which potentially leads to 38 more spaces occupied on the street. I would like to my think that I am not the only neighbor in this area who feels this way. I hope the planning commission is fully aware of the problems they are unleashing on this area with the addition of 38 apartment units and the potential of double the people that could easily come with those units.
