Construction of pergola inside fence line on the south-east side of the house (photos 1 and 2). Additional photos from back (photos 3 and 4).

Plan is to establish the pergola area as a garden feature by growing climbing white-flowering Clematis up/over the structure, thereby providing shade above the seating area, cover from rain, and an old garden feature (example photo 5). White clematis blooms will visually pair well with the white Azalea bushes planted at the front of the house. The pergola also provides structure to add soft lighting for outdoor gathering (example photo 6).

Pergola gardens featured strongly in the Arts and Crafts movement, which is consistent with the style of the home at 3833 Hermitage.
