REASON: The U.S. Department of Justice approved the City of Richmond's proposal to the FY 22 Office of Justice Programs' Community Based Violence Intervention and Prevention Initiative and awarded the city \$1,966,278.00. The Office of the Deputy Chief Administrative Officer for Human Services is seeking approval for the Chief Administrative Officer to accept the \$1,966,278.00 to fund the Gun Violence Prevention initiatives proposed within the grant.

RECOMMENDATION: The City Administration recommends adoption.

BACKGROUND:

In 2021, Mayor Levar Stoney formally announced an effort to bring a diversity of stakeholders around the table to collaborate on solutions to reduce gun violence in the city, resulting in the Richmond Gun Violence Prevention and Intervention Steering Committee and their subsequently developed "GVPI Framework." Richmond's first Community Safety Coordinator is in place to help coordinate the GVPI Steering Committee and to support the fundamentals of the city's GVPI Framework. The City's successful proposal to the U.S. Department of Justice titled "Youth Shape the Future: Enhancing Richmond VA's community-centered framework for reducing gun violence" seeks to build on these existing efforts through the following initiatives:

- 1) Enhance the Framework and support the steering committee with a rigorous strategic plan.
- 2) Enhance, expand, and integrate key youth prevention and intervention strategies of the framework including: Youth Justice, We Matter, and a new LIFT Messenger program for youth.

Residents were clear during the development of the framework: young people and those that care for them are looking for more positive youth development activities. The programs presented within this application focus on supporting young people at great risk of engaging in negative behaviors and supporting them so that they are able to have productive, thriving lives outside of the justice system. The City intends to leverage this grant opportunity to deepen the scope of programs that are working; implement a new, evidence-based program; and ensure that all components and the agencies that manage them are integrated and supporting one another. The project includes a three year independent evaluation of these Gun Violence Prevention initiatives to be led by VCU's Survey and Evaluation Research Lab (SERL).

FISCAL IMPACT / COST: The project will be paid for by grant funds from U.S. Department of Justice, not to exceed \$1,966,278.00
