Call to Order

Council President Cynthia Newbille called the meeting to order at 6:21 p.m. and presided.

Invocation was offered by Pastor MiRhang Baek of Ginter Park United Methodist Church, 1010 W. Laburnum Avenue, Richmond, Virginia.

Members of Council and the audience recited the Pledge of Allegiance.

Chamber Emergency Evacuation Plan Announcement and Citizen Speaker Guidelines

Upon the President's request, Deputy City Clerk RJ Warren provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency along with citizen speaker guidelines.

Electronic Participation

Pursuant to Rule III(D)(4)(b) of Council's Rules of Procedure, Councilor Katherine Jordan made a request to participate in the meeting via Microsoft Teams from her home, due to a medical condition that prevented her physical attendance. The Councilmembers present were required to adopt a motion to approve Councilor Jordan's participation in the meeting by electronic communication means if it appeared to the body that her request complied with Rule III(D) of Council's Rules of Procedure. A motion was solicited from those members physically assembled to approve Councilor Jordan's participation in this meeting by electronic communication means.

Citizen Comment

[CD.2022.388](#) December 12, 2022 Citizen Comment Period Speakers List

Marilynn Joyner addressed Council and stated that several vehicles have crashed into her home due to speeding on Monteiro Street. Ms. Joyner requested that the city install speed tables on 1st Street as it approaches Monteiro Street.

Vice President Ellen Robertson stated that she parked her car near Ms. Joyner's residence to observe traffic on Monteiro Street. Vice President Robertson informed Ms. Joyner that she would work with city administration to address the traffic and safety issues on Monteiro Street.

Councilor Ann-Frances Lambert stated that she would work with city administration to help address the safety issues on Monteiro Street.

Christopher Rashad Green addressed Council and stated that he was speaking in support of Marilynn Joyner. Mr. Green also stated that he was a neighbor of Ms. Joyner's, and he informed Council that action was necessary to address traffic safety on Monteiro Street.

Mary Beth Willis addressed Council and stated her concerns with the planned development of a Sheetz food and gas station in the Stratford Hills neighborhood. Ms. Willis informed Council that she did not believe the Sheetz development adhered to the Richmond 300 Master Plan, and that the business was out of sync with the surrounding buildings and homes.

Anna Medinger addressed Council and stated her concerns with the planned development of a Sheetz food and gas station in the Stratford Hills neighborhood. Ms. Medinger also stated that she was concerned that citizens were not receiving the same response from city government as developers were. Ms. Medinger further stated that she did not believe the proposed Sheetz development adhered to the Richmond 300 Master Plan.

Dexter Brown addressed Council and stated that he did not believe the proposed Sheetz food and gas station development adhered to the Richmond 300 Master Plan. Mr. Brown requested that the city partner with Stratford Hills residents to stop the Sheetz development. Mr. Brown also stated his concerns with increased traffic, potential loss of jobs at surrounding businesses, and increased noise and crime if the proposed development is completed.

Councilor Kristen Nye stated she appreciated citizens that spoke to the Sheetz development. Councilor Nye also stated that the project did not require city approval and that the city could not take action to prevent it. Councilor Nye further stated that information was provided to residents to explain why the city could be subject to legal action if it attempted to stop the development.

Michael Beiro addressed Council and stated that he was a neighbor of Marilynn Joyner. Mr. Beiro also stated that his young family was fearful of potential car accidents on his property due to speeding issues on Monteiro Street. Mr. Beiro also informed Council of the impact of traffic accidents on his home, and he requested that the city take any action necessary to address traffic safety.

Councilor Andreas Addison stated that he believed radar speed cameras could be used to address the speeding issues on Monteiro Street.

Emmett J. Jafari addressed Council and stated his concerns with Maggie Walker High School serving as a Virginia Governor's School.

Wyatt Gordon addressed Council and stated that he was a neighbor of Marilyn Joyner. Mr. Gordon also stated that speeding on the 1st Street Bridge as it approaches Monteiro Street was a safety concern with many residents on Monteiro Street, and he informed members that he does not feel safe when crossing the 1st Street Bridge. Mr. Gordon requested that the city install three speed tables to address the speeding on Monteiro Street.

Councilor Michael Jones stated that it was important that Council and the city take quick action to address citizens' concerns regarding traffic and speeding on Monteiro Street.

Councilwoman Reva Trammell informed Council that she had issues with traffic on Warwick Road that the city should also address. Councilwoman Trammell also requested that consideration of RES. 2022-R073 occur earlier on the meeting's agenda due to convenience store owners being present to provide comment.

It was the consensus of Council to consider RES. 2022-R073 as the first item on the meeting's Regular Agenda, and to permit an additional individual to address Council during the Citizen Comment Period.

Gail Valentine addressed Council and stated that it was important the city work to assist the homeless population in the city.

Councilor Stephanie Lynch stated that the city needed to do better to assist homeless individuals in the city and that more action was necessary to provide shelter.

Public Hearing

Ted Fango Moody spoke in support of ORD. 2022-322, and spoke to the legacy of Judge Willard H. Douglas, Jr.

James J.J. Minor, National Association for the Advancement of Colored People (NAACP) Richmond Branch President, spoke in support of ORD. 2022-322, ORD. 2022-325, ORD. 2022-323, and ORD. 2022-321, and he provided his experiences with the individuals referenced in the proposed street designations.

Reverend Sylvester Turner, St. Paul's Episcopal Church, spoke in support of ORD. 2022-322, ORD. 2022-321, and ORD. 2022-323. Reverend Turner addressed his experiences with Harold Harris, referenced in ORD. 2022-232.

Pastor MJ Jefferson, Blessed Hope Baptist Church, spoke in support of ORD. 2022-321 and ORD. 2022-323, and stated that he was grateful for both Dr. Kenneth E. Dennis, Sr., and Harold Harris.

Reverend Donte' McCutchen, Love Cathedral Community Church, spoke in support of ORD. 2022-321, and he stated that Dr. Kenneth E. Dennis, Sr., was a mentor to him and other youth that resided in North Jackson Ward.

Pastor Rodney Hunter, Wesley Memorial United Methodist Church, spoke in support of ORD. 2022-322, and addressed Judge Willard H. Douglas, Jr.'s history with helping individuals in need in the city.

George Lee spoke in support of ORD. 2022-321, and stated that he was very proud that the city decided to honor Dr. Kenneth E. Dennis, Sr.

Lindsey Davis Godfrey spoke in support of ORD. 2022-320, and she discussed the impact that her father, Langston R. Davis, Sr., had on the city.

Langston Davis, Jr., spoke in support of ORD. 2022-320, and he addressed the impact that his father, Langston R. Davis, Sr., had on promoting minority businesses in the city.

Cornelius Hunt spoke in support of ORD. 2022-323, and informed Council of the impact Harold Harris had on him while he was a youth in the city.

Charles Willis, United Communities Against Crime Executive Director, spoke in support of ORD. 2022-321, and stated his appreciation of Dr. Kenneth E. Dennis, Sr.

Charles Ware spoke in support of ORD. 2022-319, and stated he was a white water boater that often paddled under the Mayo Bridge while boating in the James River. Mr. Ware also addressed his concerns regarding the Mayo Bridge replacement project that he wanted addressed if ORD. 2022-319 was adopted.

Monika Beards spoke in support ORD. 2022-324, and stated that Richard and Bessie Jones, referenced in ORD. 2022-324, were her grandparents. Ms. Beards also stated that her grandparents' house was an anchor of the Randolph Community.

Councilor Ann-Frances Lambert stated her appreciation for individuals that provided comments, and informed member that she was honored to patron ORD. 2022-320, ORD. 2022-321, and ORD. 2022-322.

All members of Council requested to be added as co-patrons to ORD. 2022-320, ORD. 2022-321, ORD. 2022-322, and ORD. 2022-323

Vice President Ellen Robertson requested to be added as a co-patron ORD. 2022-319 and ORD. 2022-329.

There were no further comments or discussions and the Consent Agenda was unanimously adopted.

The Regular Agenda

The following resolution was considered:

55. [RES. 2022-R073](#) To declare a public necessity to amend ch. 30 of the City Code and to initiate an amendment to the City's zoning ordinance to make such lawful changes as may be necessary to exclude convenience stores from the permitted use of grocery stores, convenience stores and specialty food and beverage stores in all zoning districts where that use is permitted and to provide instead that convenience stores be regulated through either a neighborhood-based convenience store overlay district applied to such areas of the city as the Director of Planning and Development Review may deem appropriate to recommend or the conditional use permit process by requesting that the Chief Administrative Officer cause to be conducted a study thereof.

Patrons: Vice President Robertson, Ms. Lambert, Mr. Addison and Ms. Trammell

Councilor Ann-Frances Lambert provided an introduction and additional background information regarding RES. 2022-R073.

Public Hearing

Ezaddin Alasad, Yemeni American Merchants Association President, stated that he did not oppose RES. 2022-R073, but he requested that business owners be included in discussions regarding policies and legislation that would impact convenience store businesses in the city. Mr. Alasad also stated that members of his association work to keep businesses and customers safe, and that the association would work with the city to address any safety concerns.

Woody Alasad stated that he was a business owner that invests and lives in the city. Mr. Alasad also stated that he consults with the Richmond Police Department (RPD) regarding security, and further stated that RPD informed him that staffing issues prevented additional police presence at convenience stores.

Charles Willis, United Communities Against Crime Executive Director, spoke in support of RES. 2022-R073, and stated it would help increase safety in the city.

James J.J. Minor, National Association for the Advancement of Colored People (NAACP) Richmond Branch President, spoke in support of RES. 2022-R073. Mr. Minor also stated that he believed many convenience stores in the city try to provide a safe and healthy environment, but that the resolution would address the certain stores that sell expired unhealthy food and were prevalent of crime or susceptible to crime.

Lawrence Landon stated that he supported locally owned businesses in the city.

Camden Lashari stated that he was a convenience store owner in the city, and he requested that the city not generalize all convenience stores in the city. Mr. Lashari also stated that he understood that some stores did not act in the best interest of citizens. Mr. Name further stated that city residents should report any illegal actions to the appropriate city government agencies.

Redwan Safe stated that he believed the proposed resolution harshly targeted convenience stores in the city. Mr. Safe also stated that crimes also occur at other business, and that convenience store owners were also the victims of crimes that occur on store property.

Vice President Ellen Robertson stated the intent of the resolution was to collect information to better understand if a change to neighborhood based convenience store zoning was necessary to address safety in the city. Vice President Robertson also stated that she believed the action would lead to improved relations between residents and store owners.

Councilor Ann-Frances Lambert stated that stores that followed the rules should remain open, and that the city needed to identify ways to provide healthy foods to Richmond families. Councilor Lambert also stated that stores should not be open 24-hours a day in areas of concentrated poverty.

Councilor Michael Jones stated that he supported RES. 2022-R073, but wanted to ensure that the action carried out would not infringe upon the rights of minority business owners. Councilor Jones also stated that certain stores had prevalent criminal activity, and he stated his concerns with stores selling expired food to customers. Councilor Jones further stated that business owners needed to address safety issues independently.

President Cynthia Newbille stated that she supported RES. 2022-R073, and the continued conversations between convenience store owners and city government.

Councilwoman Reva Trammell stated that she would work with city administration regarding outreach to convenience store owners. Councilwoman Trammell requested to be added as a co-patron of RES. 2022-R073.

There were no further comments or discussions and RES. 2022-R073 was unanimously adopted.

Kevin Vonck, Department of Planning and Development Review Director, provided an introduction and additional background information regarding the proposed ordinance.

Public Hearing

Justin Perry spoke in opposition of ORD. 2022-232, and stated that he was concerned about the impact the special use permit would have on his neighborhood. Mr. Perry also stated that the design of the proposed development was not consistent with other historic single family homes in the area. Mr. Perry further stated his concerns that the special use permit would set a precedent for developers to purchase and demolish single family homes in the city.

Boz Boschen spoke in opposition of ORD. 2022-232, and stated that the proposed special use permit was an extreme development plan. Mr. Boschen also stated that the developer did not make concessions neighbors requested. Mr. Boschen recommended that Council deny the special use permit.

Art Seidenberg spoke in opposition of ORD. 2022-232, and stated his concerns with traffic safety in his neighborhood if the special use permit referenced in ORD. 2022-232 was approved. Mr. Seidenberg informed Council he was concerned that cyclists and pedestrians could be struck from vehicles leaving the garage of the proposed structures.

Bob Englander spoke in support of 2022-232, and informed Council that he was the developer of the proposed structures referenced in the ordinance. Mr. Englander stated that his team met with the Museum District Association and surrounding neighbors several times to address residents' concerns.

Will Payne spoke in support of 2022-232, and informed Council that he was the architect of the proposed structures referenced in the ordinance. Mr. Payne stated that his team agreed to certain design concessions that he believed addressed neighbors' concerns. Mr. Payne also stated that the development would lead to more housing opportunities in the city.

John White, 510 Architects owner, spoke in support of ORD. 2022-232, and stated the design of the proposed development incorporated the concerns of neighbors. Mr. White also stated that he believed the proposed development adhered to the city's Richmond 300 Master Plan.

Councilor Ann-Frances Lambert requested additional information from the development's architect, Will Payne, regarding cars exiting garages in relation to safety.

Councilor Andreas Addison addressed the history of the real estate property located at 3301 and 3303 Park Avenue, and he also addressed the history of the special use permit referenced in ORD. 2022-232. Councilor Addison stated that he believed the development team did not adequately engage with concerned neighbors throughout the special use permit process. Councilor Addison also stated that he believed the development team did all the necessary requirements to have the special use permit approved, but he noted his frustration with how the process proceeded and the potential precedent resulting from approval.

Kevin Vonck, Department of Planning and Development Review Director, provided information regarding the special use process. Mr. Vonck also addressed similar requests pending with the Department of Planning and Development Review, and other lots in the city that could be subject to development similar to the project referenced in ORD. 2022-232.

Councilor Katherine Jordan stated that she opposed the special use permit referenced in ORD. 2022-232, and informed Council that she was concerned about the precedent that would be set by adopting the ordinance.

There were no further comments or discussions and ORD. 2022-232 was adopted: Ayes 6, Addison, Nye, Lynch, Trammell, Robertson, Newbille. Noes 2, Jordan, Jones. Lambert was excused.

Councilwoman Trammell also stated that she was concerned that the current real estate tax rate would lead to more evictions and an increase to the city's homeless population.

CAO Saunders stated that the rebate would be provided to all parcel owners in the city. CAO Saunders also stated that the rebate would provide immediate relief to residents. CAO Saunders further stated that the city was concerned about the impact of a potential recession in relation to the city's real estate tax rate. CAO Saunders informed Council that rebate checks would be mailed to residents in January 2023.

Councilor Kristen Nye stated that the rebate was a short-term fix for city residents, but she informed Council that she would vote to adopt the proposed ordinances.

Councilwoman Trammell stated that she would vote to adopt the proposed ordinances to provide residents with some relief.

Vice President Ellen Robertson requested that city administration provide a presentation and additional information regarding the city's process for aligning the city's real estate assessment schedule with the city's budgeting process.

CAO Saunders stated that city administration would work to provide information regarding the process in January, 2023.

There were no further comments or discussions and ORD. 2022-303, ORD. 2022-304, and ORD. 2022-304 were unanimously adopted.

Councilor Ann-Frances Lambert requested additional information regarding the process of appropriating funding to non-departmental programs and the city's non-profit partners.

Councilor Lambert also requested additional information regarding the status of Commonwealth Catholic Charities and the Salvation Army's emergency shelter locations in the city.

CAO Saunders stated he would provide information regarding non-departmental and non-profit allocations. CAO Saunders also stated that work was in process regarding emergency shelter locations in the city.

Councilor Stephanie Lynch stated her appreciation for the organizations associated with the Greater Richmond Continuum of Care (GRCoC) that would receive funding through the adoption of ORD. 2022-349.

Public Hearing

Anita Bennett, Daily Planet Health Services Acting Chief Executive Officer, spoke in support of ORD. 2022-349, and stated that the ordinance would help fund the city's inclement weather shelter. Ms Bennett informed Council that the Daily Planet provides services at the city's inclement weather shelter site.

Clara Stokes, CARITAS Chief Development Officer, spoke in support of ORD. 2022-349, and stated that CARITAS looked forward to assisting with providing shelter to the city's homeless population year-round.

Kelly King Horne, Homeward Executive Director, spoke in support of ORD. 2022-349, and stated that the funding referenced in the proposed ordinance was an investment of city funds to address homelessness in the city.

Annette Cousins, GRCoC Chair, spoke in support of ORD. 2022-349, and stated the funding referenced in the ordinance was a significant investment in the GRCoC's coordinated homeless services system. Ms. Cousins also stated that the funding was the most efficient way to addresses homelessness in the Richmond region.

Geri Archer, RVA Sister's Keeper Co-Owner, spoke in support of ORD. 2022-349, and stated her appreciation for the city working with GRCoC entities to provide services to city residents.

Dr. Patricia Cook, MD, Daily Planet Chief Medical Officer, GRCoC Board Member, spoke in support of ORD. 2022-349, and stated her appreciation for the investment the city was making to address homeless services in the city.

President Cynthia Newbille stated her appreciation for the organizations involved with the GRCoC, and for their efforts to address homelessness in the city.

Councilor Ann-Frances Lambert stated her appreciation for the organizations involved with the GRCoC.
