

PURPOSE: To amend Ordinance 2022-056, which adopted the Fiscal Year 2022-2023 Special Fund Budget by re-appropriating \$72,000 from the Fire & Emergency Services Special Fund Budget to the Department of Emergency Communications Special Fund Budget. The following Special Funds will be moved FFY21 SHSP Public Housing Kits (\$30,000), FFY21 SHSP Richmond CERT (\$12,000), and FFY21 SHSP Public Outreach and Education (\$30,000).

REASON: On October 10, 2022, Resolution 2022-R062 adopted the Mayor's appointment of Mr. Stephen Willoughby, Director of Emergency Communications, as Emergency Management Coordinator for the City of Richmond. As such, the Office of Emergency Management was moved from the Department of Fire and Emergency Services into the Department of Emergency Communications, reporting thenceforth to Director Willoughby. This paper requests to move grant funding associated with the Office of Emergency Management from the Fire and Emergency Services Special Fund Budget to the Department of Emergency Communications Special Fund Budget.

RECOMMENDATION: City Administration recommends adoption.
