PURPOSE: To authorize the Chief Administrative Office to accept funds in the amount of \$85,630.00 through Virginia Department of Emergency Management (VDEM) from the Department of Homeland Security FEMA Local Emergency Management Performance Grant (LEMPG) Program and appropriate these funds to the Department of Emergency Communications' FY2023 Special Fund Budget to a new special fund titled FFY22 LEMPG.

REASON: DHS/FEMA annually awards LEMPG funding to state, local, tribal, and territorial entities. LEMPG funding to Virginia localities is distributed by VDEM.

RECOMMENDATION: The City Administration recommends adoption of this Ordinance.

BACKGROUND: LEMPG awards are based on locality population data. These funds support daily operation and enhancement of Emergency Management program core capabilities: prevention protection, mitigation, response and recovery and outreach/educational activities citywide, maintenance and enhancement of Emergency Operations Center (EOC), alternate EOC, Mobile Command Post, and other response assets (generator, trailers, and western shelter systems.)

Program Objectives:

The purpose of the EMPG is to provide federal funds to states to assist in preparing for all hazards, as authorized by Section 662 of the Post Katrina Emergency Management Reform Act (6 U.S.C. § 762) and the Robert T. Stafford Disaster Relief and Emergency Assistance Act (42 U.S.C. §§ 5121 et seq.). Title VI of the Stafford Act authorizes DHS/FEMA to make grants for the purpose of providing a system of emergency preparedness for the protection of life and property in the United States from all hazards and to vest responsibility for emergency preparedness jointly in the federal government, states, and their political subdivisions. The federal government, through EMPG, provides direction, coordination, and guidance, and provides necessary assistance, as authorized in this title, to support a comprehensive all-hazards emergency preparedness system.

The FY2022 Emergency Management Performance Grant (EMPG) will provide federal funds to assist emergency management agencies to obtain the resources required to support implementation of the National Preparedness System and the National Preparedness Goal (the Goal) of a secure and resilient nation. Among the five basic homeland security missions noted in the DHS Quadrennial Homeland Security Review, EMPG supports the goal to Strengthen National Preparedness and Resilience. EMPG supports comprehensive, allhazards emergency preparedness system by building and sustaining the core capabilities contained in the Goal. EMPG funding is used to support a whole community approach to strengthen a state's or community's emergency management program. Examples of tangible EMPG funded activities include:

Conducting risk assessments, assessing capabilities, identifying preparedness needs, and updating emergency plans;

Building or augmenting core capabilities;

Designing and conducting exercises that engage the whole community of stakeholders to validate core capabilities;

Conducting emergency management training; and

Providing funding support for emergency management personnel.

VDEM recognizes the critical role of emergency management at the local level. Strong local emergency management programs keep the Commonwealth safer, and allow state and local government to respond and recover effectively and efficiently when an emergency or disaster occurs. The objective of the EMPG, then, is to support your locality's efforts to develop and maintain a Comprehensive Emergency Management Program.

Cost Share/Match

The federal share that is used towards the LEMPG Program budget must be at least 50 percent of the total budget. The subrecipient must equally match (cash or in-kind) the federal contribution pursuant to Sections 611(j) and 613 of the Robert T. Stafford Disaster Relief and Emergency Assistance Act (Pub. L. No. 93-288), as amended, (42 U.S.C. §§ 5121et seq.). Unless otherwise authorized by law, federal funds cannot be matched with other federal funds. FEMA administers cost matching requirements in accordance with 2 CFR §200.306 located at <u>https://www.ecfr.gov</u>. To meet matching requirements, the contributions must be verifiable, reasonable, allocable, and necessary under the grant program and must comply with all federal requirements and regulations.

Management and Administration (M&A): Your local emergency management agency may retain and use up to five percent of the award for local management and administration purposes. M&A activities are those directly related to managing and administering SHSP Program funds, such as financial management and monitoring. It should be noted that salaries of local emergency managers are not typically categorized as M&A, unless the local emergency management agency chooses to assign personnel to specific M&A activities.

Indirect (Facilities & Administrative [F&A]) Costs: Indirect costs are allowable under this program, as described in 2 C.F.R. § 200.414. With the exception of recipients who have never received a negotiated, indirect cost rate as described in 2 C.F.R. § 200.414(f), recipients must have an approved indirect cost rate agreement with their cognizant Federal agency to charge indirect costs to this award. A copy of the approved rate (a fully executed, agreement negotiated with the applicant's cognizant Federal agency) is required at the time of application, and must be provided to FEMA before indirect costs are charged to the award.

Reporting: Subrecipients are obligated to submit Quarterly Progress Reports as a condition of their subaward. Quarterly progress reports must be submitted via your vdem.emgrants.com account within 15 days following the end of the quarter. The schedule for reporting is as follows:

Within 30 days following the end of the period of performance, subrecipients must upload a Final Progress Report detailing all accomplishments throughout the Period of Performance in vdem.emgrants.com account. After this report has been submitted, reviewed and approved by the Grants Office, a close-out notice will be issued which will indicate the period of performance as closed, list any remaining funds that will be deobligated, and address the record retention requirements for grant records. The subrecipient must return any funds that have been drawn down, but remain unliquidated in its financial records.

Period of Performance Extensions: Extensions to this program are allowed. Extensions to the initial period of performance identified in the subaward will only be considered through formal, written requests addressed to VDEM, and must contain specific and compelling justifications as to why an extension is required. Subrecipients are advised to coordinate with the Grant Administrator, as needed, when preparing an extension request. All extension requests must address the following:

- 1. Grant program, fiscal year, and subaward ID number in vdem.emgrants.com
- 2. Reason for delay that must include details of the legal, policy, or operational challenges that prevent the final outlay of awarded funds by the applicable deadline
- 3. Current status of the activity/activities
- 4. Approved period of performance termination date and new project completion date
- 5. Amount of funds drawn down to date
- 6. Remaining available funds, both Federal and non-Federal
- 7. Budget outlining how remaining Federal and non-Federal funds will be expended
- 8. Plan for completion, including milestones and timeframes for achieving each milestone, and the position/person responsible for implementing the plan for completion
- 9. Certification that the activity/activities will be completed within the extended period of performance without any modification to the original Statement of Work, as described in the approved budget

Extension requests will be granted only due to compelling legal, policy, or operational challenges. Extension requests will only be considered for the following reasons:

- Contractual commitments by the grant recipient with vendors or subrecipients prevent completion of the project within the existing period of performance.
- The project must undergo a complex environmental review that cannot be completed within existing period of performance
- Projects are long-term by design and therefore acceleration would compromise core programmatic goals
- Where other special circumstances exist
