**PURPOSE:** To authorize the Chief Administrative Officer, for and on behalf of the City of Richmond ("the City"), to (i) execute a Memorandum of Understanding (see **Attachment A**) between the City, the County of Henrico, and the County of Chesterfield that confirms the agreement between the localities to contract with the Corporation for Supportive Housing to collaboratively prepare HOME Investment Partnerships Program – American Rescue Plan (HOME-ARP) Allocation Plans and, (ii) thereafter, to enter into a contract, by way of cooperative procurement, with the Corporation for Supportive Housing for the development of the City's HOME-ARP Allocation Plan. And, to appropriate \$57,171.95. of the \$5,840,854 allocated to the City via the HOME-ARP funds for the development of the City's HOME-ARP Allocation Plan.

**REASON:** To support a regional approach to addressing homelessness by jointly developing plans for the use of one-time funding from the U.S. Department of Housing and Urban Development (HUD) with Chesterfield and Henrico Counties.

**RECOMMENDATION:** Approval is recommended by the City Administration.

**BACKGROUND:** In the federal fiscal year 2021, HUD allocated the City of Richmond \$5,840,854 from the Department's HOME Investment Partnerships Program – American Rescue Plan (HOME-ARP). This one-time, formula-based funding is intended to help jurisdictions address homeless assistance needs by creating or preserving affordable housing; providing tenant-based rental assistance; funding supportive services, including homelessness prevention services and housing counseling; or purchasing or developing non-congregate shelters. To receive the \$5,840,854, the City must update its annual HOME Action Plan to describe the proposed use of the one-time HOME-ARP funds. This update is known as the "HOME-ARP Allocation Plan."

The City of Richmond, Chesterfield County, and Henrico County seek to collaborate on the development of a regional approach. While each locality must develop and submit its own HOME-ARP Allocation Plan, the plans will be developed jointly to maximize collaboration and efficiency. Given the fact that housing insecurity is not a challenge that stops at jurisdictional borders. Neighboring localities can more effectively and efficiently serve their residents through a strengthened collaboration to identify and implement solutions on a regional basis. In a letter dated December 13, 2021, the three localities confirmed their intent to collaborate in efforts to reduce regional homelessness – see **Attachment B**.

To that end, Chesterfield issued a Request for Proposals ("RFP") to find a consultant to help the localities develop their HOME-ARP Allocation Plans. The RFP permits Henrico and Richmond to obtain similar services from the selected consultant. Chesterfield selected the Corporation for Supportive Housing. The Corporation for Supportive Housing is a national non-profit whose mission is "to advance solutions that use housing as a platform for services to improve the lives of the most vulnerable people, maximize public resources and build healthy communities." Amongst other competencies, the Corporation for Supportive Housing provides customized community planning services. On August 9, 2022, Henrico entered into an agreement with the Corporation for Supportive Housing.

Richmond, by way of this ordinance, seeks to (i) sign a Memorandum of Understanding with Chesterfield and Henrico confirming its commitment to collaborating to reduce regional homelessness by participating jointly in certain tasks and activities that the Corporation for Supportive Housing will perform pursuant to the Service Agreement.<sup>1</sup> Those tasks include a needs assessment and gap analysis; stakeholder consultation; capacity building; and creation and presentation of HOME-ARP Allocation Plans. Additionally, by signing the MOU, Richmond will commit to paying for its share of the development of the HOME-ARP Allocation Plans: an estimated \$57,171.95.

#### MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding ("Memorandum") is made the \_\_\_\_\_ day of September, 2022, between the County of Henrico, Virginia ("Henrico"), City of Richmond, Virginia ("Richmond"), and the County of Chesterfield, Virginia ("Chesterfield"). This Memorandum sets out the agreement between the parties regarding certain tasks to be performed by the Corporation for Supportive Housing pursuant to Chesterfield Service Agreement #ADMN22000272 for Consultant Services for Development of HOME-ARP Allocation Plan dated June 1, 2022 (the "Service Agreement").

#### **Recitals**

A. By letter dated December 13, 2021, Henrico, Richmond, and Chesterfield stated their intent to collaborate in efforts to reduce regional homelessness.

B. To that end, Chesterfield issued Request for Proposal No. ADMN22000272 ("RFP") to solicit proposals for Consultant Services for the Development of HOME-ARP Allocation Plan. The RFP contained language in accordance with Va. Code § 2.2-4304(B) that would permit Henrico and Richmond to obtain similar services from the selected consultant. Chesterfield selected the Corporation for Supportive Housing and entered the Service Agreement.

C. On August 9, 2022, Henrico and Corporation for Supportive Housing agreed to use, by way of cooperative procurement, the Service Agreement for consultant services for the development of the HOME-ARP Allocation Plan.

D. On \_\_\_\_\_\_, 2022 the City of Richmond and the Corporation for Supportive Housing agreed to use, by way of cooperative procurement, the Service Agreement for consultant services for the development of the HOME-ARP Allocation Plan

E. For the parties' mutual convenience, and in the interest of efficiency and collaboration, Henrico, Richmond, and Chesterfield intend to participate jointly in certain tasks and activities ("Tasks") that the Corporation for Supportive Housing will perform pursuant to the Service Agreement. The Corporation for Supportive Housing will invoice Chesterfield for the Tasks, and Henrico and Richmond are willing to contribute towards their share of the cost for the Tasks. The Tasks are detailed in <u>Exhibit A</u> to this Memorandum.

#### Agreement

NOW, THEREFORE, for and in consideration of the foregoing recitals and other good and valuable consideration set forth below, the parties agree as follows:

1. In consultation with Henrico and Richmond staff, Chesterfield staff will coordinate the Tasks with the Corporation for Supportive Housing and require the Corporation for Supportive Housing to perform the Tasks as specified in <u>Exhibit A</u>, which is attached to and made a part of

this Memorandum. The Tasks are as follows: (i) Project Launch and Management, (ii) Needs Assessment and Gaps Analysis, (iii) Stakeholder Consultation, (iv) HOME-ARP Allocation Plan for Richmond, and (v) Presentation of Findings.

2. Subject to necessary approvals for appropriations, Richmond will contribute \$57,171.95 for its share of the cost for the development of the required HOME-ARP Allocation Plan.

Dear Joe and Lincoln:

This letter is to confirm our discussions regarding local uses of federal HOME-ARP funds for regional projects serving "qualifying populations" as defined by the U.S. Department of Housing and Urban Development's Notice CPD-21-10. As such, it is a statement of our intent, subject to all necessary approvals for appropriations and award of contracts by our governing bodies.

The City of Richmond, Chesterfield County, and Henrico County have a total allocation of \$11,181,755 of HOME-ARP funds. These allocations are \$5,840,854 for Richmond, \$3,216,865 for Henrico, and \$2,124,036 for Chesterfield. Fund recipients may allocate up to 15% of their fund allocation for administrative costs.

We have jointly agreed on good faith collaboration among our localities to target these funds to reduce regional homelessness. To that end, Chesterfield will issue a Request for Proposal (RFP) for consultant services to study needs and recommend projects to serve Chesterfield residents and develop a HOME-ARP Allocation Plan consistent with the requirements in the HUD Notice CPD-21-10. The RFP will contain language in accordance with Va. Code § 2.2-4304(B) that would permit Richmond and Henrico to purchase similar services under that cooperative contract.

After receipt of responsive proposals to the RFP, the plan is that Chesterfield will contract with the chosen consultant, and Henrico and Richmond may execute separate contracts with the consultant. Once the consultant's recommendations are received, the localities shall consult and jointly select eligible projects best suited to use HOME-ARP funds to address the needs of qualifying populations.

As part of this process, and with the approval of our governing bodies, each locality will submit to the United States Department of Housing and Urban Development for review, a HOME-ARP Allocation Plan as an amendment to its FY 2021 Annual Action Plan. Prior to submitting the Amendment to the FY 2021 Annual Action Plan each locality agrees to work together to identify regional projects.
