On January 26th and February 13th, 2023, Council's Land Use, Housing & Transportation committee and City Council respectively are scheduled to take up RES. 2023-R005 "To adopt the City of Richmond RVAgreen 2050: Climate Equity Action Plan 2030 as the official sustainability plan for the City of Richmond". As the City's public health professionals, we write to document our assessment of some local public health impacts related to climate change and the impact adopting this resolution would have on local public health.

Our staff at Richmond Henrico Health Districts is monitoring the projected and current health impacts associated climate change in our community. Evidence supports that there are active negative health impacts experienced in Richmond related both to the pollution that contributes to climate change and the environmental factors exacerbated by climate change. Changes in climate are expected to continue, with likely amplification or worsening of associated health impacts already seen. Health-related data to support this assessment include:

- In 2022, the Virginia Department of Health recorded 114 heat-related illness (HRI) visits in the City of Richmond.² HRI visits have been increasing on-average since the first report in 2015, with the most HRIs recorded in 2021 at 117.² Evidence supports that the health impacts are higher than what HRI data captures, with overall healthcare utilization increasing in Virginia when the maximum daily heat index reaches 26C/79F or higher.³
- In 2021, ozone levels were found to contribute to 4 excess mortalities and 15 excess morbidities in Richmond City.⁴
- In 2021, Richmond City ranked #1 in the U.S. by Asthma Capitals for individuals impacted by pollen, with pollen expected to increase with warmer weather and longer warm seasons as a result of escalating climate change.⁵
- Richmond residents experience chronic diseases that can be triggered and/or exacerbated by environmental burdens increased by climate change. This includes 13.6% of Richmond adult residents reporting an asthma diagnosis as of 2020,6 12.2% for diabetes in 2019, 35.1% for high blood pressure in 2019, and 17.2% for experiencing mental distress during last 30 days in 2019.7
- Lower income communities and communities of color often experience higher environmental burdens that are further exacerbated by climate change. This is seen in Richmond where many historically redlined communities experience higher heat levels and heat vulnerability than other neighborhoods. Also, some residents are more likely to experience negative health outcomes due to exposure and/or increased vulnerability, including children, older adults, those with chronic diseases, those experiencing homelessness, and those working outdoors.

The proposed Climate Equity Action Plan 2030, for which RES. 2023-R005 asks the Council's support, includes interventions essential towards achieving climate adaptation and resilience necessary to protect public health. This includes interventions in the categories designed to address pollution that contributes to climate

change and the downstream impacts of climate change. The action plan includes important emphasis on environmental justice to address and reduce inequities exacerbated by climate change. Our staff also supported plan creation and refinement per the Office of Sustainability, including participating in workgroups and providing feedback on the plan draft. Lastly, the adoption of RES. 2023-R005 will align with existing Richmond City work around climate, planning, and the built environment, including alignment with Richmond 300 goals and Council's RES 2021-R049.

Given the health impacts related to climate change, adopting RES. 2023-R005 will be an essential step towards protecting community health and promoting health equity. Our staff will be available to answer questions and provide ongoing analysis as requested. Also, staff plan to participate in RVAgreen 2050 Action Plan Implementation Workgroup(s) as requested by the Richmond Office of Sustainability to continue to provide insights on public health, promote health equity, and utilize expertise in plan implementation.
