Call to Order

Council President Michael Jones called the meeting to order at 6:08 p.m. and presided.

Invocation was offered by Reverend Aaron Houghton of Forest Hill Presbyterian Church, 4401 Forest Hill Avenue, Richmond, Virginia.

Members of Council and the audience recited the Pledge of Allegiance.

Chamber Emergency Evacuation Plan Announcement and Citizen Speaker Guidelines

Upon the President's request, Deputy City Clerk RJ Warren provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency along with citizen speaker guidelines.

Action on Appointments and Reappointments

There were no appointment/reappointment items for consideration.

President Michael Jones welcomed and invited LaTesha Holmes, who was appointed Council Chief of Staff on January 9, 2023, to provide comment.

Council Chief Staff LaTesha Holmes expressed her appreciation for the welcome she received, and she stated that she looked forward to working with Council and the community.

President Michael Jones, on behalf of City Council, and Mayor Levar Stoney, proclaimed Richmond City as a Stroke Smart City and recognized the leadership role that Virginia Commonwealth University Health provided on behalf of Stroke Smart awareness.

Councilor Ellen Robertson, on behalf of City Council, honored and recognized the Hillside Court Playground+ Rehabilitation Project Team for its work on behalf of families of the Richmond Redevelopment & Housing Authority Hillside Court Community.

Citizen Comment

CD.2023.017 January 23, 2023 Citizen Comment Period Speakers List

Ben Cronly, Byrd Theatre Assistant General Manager, addressed Council and requested additional funding for Carytown. Mr. Cronly stated that Carytown was a tourist destination that promotes economic activity in the city. Mr. Cornly also stated that Carytown requires additional funding to address trash and graffiti, so that the area and local businesses remain inviting to tourists.

L. Shirley Harvey addressed Council and stated that government should not disrespect citizens. Ms. Harvey also stated that Richmond City was not established to allow gambling.

Timothy Drew addressed Council regarding public safety in the city. Mr. Drew informed Council of his willingness to assist the Richmond Police Department (RPD) but added that he was prohibited from that action due to age limits established in the Code of Virginia. Mr. Drew provided documentation of his request for an age waiver.

A copy of the material provided has been filed.

President Michael Jones thanked Mr. Drew for his comments, and he also noted his concerns with the age limit referenced by Mr. Drew.

David Mitchell addressed Council and informed members about his concerns regarding the Department of Utilities' practice of relying on estimated usage for billing. Mr. Mitchell stated that he believed the estimated usage practice was illegal, and he noted that he informed the City Attorney of his concern. Mr. Mitchell also informed Council of his intention to sue the city regarding the estimated usage practice.
