### Call to Order

Council President Michael Jones called the meeting to order at 6:03 p.m. and presided.

**Public Hearing on the Tourism Improvement District Plan**

Amishi Amin, on behalf of Shamin Hotels, TID Steering Committee Representative, spoke in support of the proposed TID and stated that the TID was supported by the hotel community.

Lars Friedriszik, Richmond Marriott Downtown General Manager, spoke in support of the proposed TID. Mr. Friedriszik stated that it would help market events at the Greater Richmond Convention Center and increase the number of tourists staying at local hotels.

John Cario, Hilton – Richmond Downtown General Manager, spoke in support of the proposed TID. Mr. Cario stated that he believed the TID would help fund the marketing and promotion of future downtown development projects.

Rick Butts, the Omni Richmond Hotel Director of Sales and Marketing, spoke in support of the proposed TID. Mr. Butts stated that competition to attract events and tourists to downtown Richmond was fierce and that the TID would help Richmond Region Tourism grow tourism in the city.

Morgan Slade, Quirk Hotel Representative, spoke in support of the TID. Mr. Slade stated that the TID would help fund the marketing of Richmond as a leisurely destination.

Kim Shuri, Dobrin Property Management, LLC Office Manager, spoke in opposition to a proposed rental inspection district program. Ms. Shuri stated she was concerned about a non-government entity administering the inspection of rental units in the city.

Jerry Blow addressed Council and spoke in support of the proposed use of the Hickory Hill Community Center as a Richmond Fire training facility. Mr. Blow informed Council that he was a previously employed firefighter with Phillip Morris and that he understood the training and sacrifice necessary for Richmond firefighters.

Keesha Haskins, McGuire Civic Association President, and Carolyn J. Johnson, McGuire Civic Association Vice President, addressed Council and stated their support for the proposed use of the Hickory Hill Community Center as a Richmond Fire training facility.

Marie Hart addressed Council and stated her support for the proposed use of the Hickory Hill Community Center as a Richmond Fire training facility. Ms. Hart also stated that she believed the majority of her neighbors supported the fire training facility.

Donald Bryant addressed Council and stated his support for the proposed use of the Hickory Hill Community Center as a Richmond Fire training facility. Mr. Bryant also stated that Richmond firefighters needed the facility and that they deserve it.

Juanita Gaines addressed Council and stated that she and the president of the Davee Gardens Civic Association supported the proposed use of the Hickory Hill Community Center as a Richmond Fire training facility. Ms. Gaines also stated that the Hickory Hill Community Center was a perfect location for the training facility.

Anna Clemens, Virginia Organizing Richmond Chapter Member, addressed Council and stated her support for the proposed rental inspection district program. Ms. Clemens referenced her experience as a renter in the city and noted her concerns with the living conditions and safety measures at certain rental properties in the city.

*Councilwoman Reva Trammell stated her appreciation for individuals that spoke in support of the proposed use of the Hickory Hill Community Center as a Richmond Fire training facility, and she also stated her own support for the proposed facility.*

*Councilwoman Trammell requested that Council permit Fire Chief Melvin Carter to read a letter from concerned citizens that could not attend the meeting.*

*It was the consensus of Council to allow Fire Chief Carter to read the letter provided.*

Fire Chief Carter recited Howard and Mary Carn's letter of support for the proposed use of the Hickory Hill Community Center as a Richmond Fire training facility.

## **Public Hearing**

Dr. Terricita Sass, Ph.D, Reynolds Community College Vice President for Enrollment Management and Student Success, spoke in support of ORD. 2023-080, and stated that Reynolds Community College was looking forward to a partnership with the city regarding the Pathways Program referenced in the proposed ordinance.

Charles Willis, Richmond Highway Neighborhood Civic Association President, United Communities Against Crime Executive Director, National Association for the Advancement of Colored People (NAACP) Second Vice President, NAACP Virginia State Conference Member, spoke in support of RES. 2023-R019, and informed Council of his concerns with landlords raising rent prices in the city.



Tracey Hardney-Scott, NAACP Virginia State Conference Housing Chair, NAACP Richmond Branch Housing Chair, Tenant Landlord Resource Center Chief Executive Officer, spoke in support of RES. 2023-R019, and informed members of her concerns with housing prices in the city. Ms. Hardney-Scott also stated that housing instabilities impact other issues throughout the city, and she requested that the city fully address housing issues once the resolution is adopted.

Bobby McIntosh addressed Council and stated his concerns regarding rental difficulties experienced by landlords and property owners.

Crystal Riley spoke in support of ORD. 2023-080, and stated that the Pathways Program referenced in the proposed ordinance would help low income residents achieve trade training, higher wage employment, and more opportunities.

*Councilor Katherine Jordan stated that the city needed to take several steps to address the housing crisis in the city, and she suggested that the city specifically address illegal short term rentals in the city through code enforcement.*

*Councilor Ann-Frances Lambert stated her appreciation for the comments provided by Ms. Riley. Councilor Lambert also stated that she believed ORD. 2023-080 and the Pathways Program would provide more career opportunities for city residents.*

*Councilor Andreas Addison addressed RES. 2023-R019 and stated that the city needed to begin fully addressing the housing crisis in the city. Councilor Addison also stated his support of ORD. 2023-080, and he informed members that he believed it would help provide more job training for Richmond Public Schools students.*

*Councilwoman Reva Trammell stated her support for providing opportunities for Richmond Public Schools students, and she informed members that she believed the prospect of job training after high school graduation would encourage students to remain enrolled in school. Councilwoman Trammell noted her request to be added as a co-patron of RES. 2023-R019.*

*Councilor Ellen Robertson stated her appreciation for RES. 2023-R019 and action taken by the Mayor to address housing in the city. Councilor Robertson also stated that housing was a complex issue that would require a lot of work to address. Councilor Robertson further stated that she supported ORD. 2023-080, and she requested to be added as a co-patron of the ordinance.*

*Councilor Cynthia Newbille stated her appreciation for Dr. Terricita Sass speaking in support of ORD. 2023-080, and providing additional information regarding the Pathways Program. Councilor Newbille requested to be added as a co-patron of ORD. 2023-080. Councilor Newbille also spoke in support of RES. 2023-R019 and noted that the city needed to ensure that a large inventory of affordable housing opportunities be available for the city's residents.*

*Vice President Kristen Nye stated her appreciation for city administration's work regarding RES. 2023-R019. Vice President Nye also stated that Council should ensure that work continues on addressing the housing crisis after adoption of the proposed resolution.*

*Councilors Addison, Jordan, Lynch, Trammell, Vice President Nye, and President Jones requested to be added as co-patrons of ORD. 2023-080.*

*President Michael Jones addressed affordable housing in the city and stated that the city must ensure that professionals working in the city have affordable housing opportunities within the city.*
