

RE: To Terminate Old City State of Emergency Declarations

ORD. OR RES. No. _____

PURPOSE: To end all previously declared local state of emergency.

REASON: Virginia State Code 11-146.21 Declaration of Local Emergency, requires that “the governing body, when in its judgement all emergency actions have been taken, shall take appropriate action to end the declared emergency”. As a part of reimagining emergency management in the City, it has been discovered that the City government has failed to rescind the emergency declarations of some of the past emergencies which had no sunset clauses contained in the resolution.

In an effort to update records of these past emergency declarations, the Coordinator of Emergency Management is requesting City Council terminate these declared emergencies that are technically still active, because all emergency actions have taken place and that an state of emergency no longer exists for these incidents.

The Coordinator of Emergency Management recommends that the following emergency declarations be terminated:

- Resolution No. 2009-R22-30: Major Snowstorm (March 2009)
- Resolution No. 2011-R93-92: Hurricane Irene
- Resolution No. 2020-R041: Civil Unrest (Summer 2020)
- Resolution No. 2021-R006: Potential Civil Unrest on Lobby Day

RECOMMENDATION: The City Administration recommends adoption.

BACKGROUND: The Virginia Emergency Services and Disaster Law Virginia Code, 44-146.21 provides that the declaration of any emergency by the local Director of Emergency Man-

agement is subject to confirmation by the local governing body at its next regularly scheduled meeting or at a special meeting within 45 days of the declaration, whichever occurs first. Furthermore, Virginia Code requires that “the governing body, when in its judgement all emergency actions have been taken, shall take appropriate action to end the declared emergency”.
