ORDINANCE/RESOLUTION SUMMARY

The patron's request is to amend Ordinance No. 2022-055 (which adopted the Fiscal Year 2022-23 General Fund Budget on May 9, 2022) to change the uses and allocation of the FY23 Third Council District Budget.

BACKGROUND

The purpose of this amendment is to comply with requirements of Va. Code Section 15.2-2503, which requires that a locality's budget stipulate how local governing body discretionary funds will be used. This Section allows individual members of the governing body to propose amendments during the fiscal year to change the uses and allocation of those discretionary funds.

The patron wishes to amend the itemized allocations of funds in the FY23 Third Council District Budget to decrease the categories of Local Mileage (\$339), Advertisements (\$319), Meetings and Events (\$1,122), and Membership Dues (\$100) balances to \$0, and decrease the Printed and Electronic Communication category by (\$160). These decreased amounts will be moved to the Grants category, resulting in a new amended budget of \$8,877 for Grants.

The Third District FY23 Anticipated District Expense List category amounts in the current budget per Ordinance No. 2022-055, adopted May 9, 2022, should be changed to reflect adjustments in the categories, as required by Va. Code Section 15.2-2503, for district

adjustments in the categories, as required by Va. Code Section 15.2-2503, for district initiatives in FY23. The purpose of this proposal is to allow clear authority to make such expenditures by amending the First Council District FY23 Anticipated Expense List.
