The purpose of this amendment is to comply with requirements of Va. This Section allows individual members of the governing body to propose amendments during the fiscal year to change the uses and allocation of those discretionary funds.

The patron request is to amend Ord. 2021-40, adopted May 24, 2021, which adopted the Fiscal Year 2021-2022 General Fund Budget to change the uses and allocation of the Council District

Funds for the Seventh District and amends the Seventh District FY23 Anticipated Council District expense list to amend the funding allocations to the categories as indicated on the Seventh District FY23 Anticipated Expense List. See attached document.
