That Ordinance No. 2022-056, adopted May 9, 2022, which adopted a Special Fund Budget for the fiscal year commencing July 1, 2022, and ending June 30, 2023, and made appropriations pursuant thereto, be and is hereby amended by creating a new special fund for the Department of Budget and Strategic Planning called the Virginia Union University Innovation Center Special Fund, for the purpose of providing such funds to Virginia Union University for the development of an "Innovation Center."

**PURPOSE:** To authorize the Chief Administrative Officer to accept funds in the amount of \$2,000,000 from Commonwealth of Virginia, State Council of Higher Education; to amend Fiscal Year 2022-2023 Special Fund Budget by creating a new special fund called the Virginia Union University Innovation Center Special Fund; and to appropriate the increase to the Fiscal Year 2022-2023 Special Fund Budget by increasing estimated revenues and the amount appropriated to Virginia Union University Innovation Center Special Fund by \$2,000,000 for the purpose of providing such funds to VUU as prescribed by the State of Virginia's Appropriations Act.

**REASON:** An ordinance is necessary to authorize the acceptance of funds from State Council of Higher Education, and to appropriate such funds to a Special Fund in order to facilitate a two disbursement to Virginia Union University.

**RECOMMENDATION:** The City Administration recommends approval.

**BACKGROUND:** On April 3, 2023, Hunton Andrews Kurth LLP notified the City of Richmond of the appropriated \$2,000,000 for Virginia Union University for the Virginia's Historically Black Colleges and Universities (HBCU) for creation and support of an Innovation Center.

The legislation directs the State Council of Higher Education for Virginia to disburse the funds allocated for Virginia Union University to the City of Richmond for distribution. The funds will be appropriated to the City, and subsequently transferred to Virginia Union University in two separate disbursements according to the attached transmittal letter. Upon Council adoption and execution of the transmittal letter the State Council of Higher Education will transfer \$1 million immediately and \$1 million on January 1, 2024. The City's sole responsibilities will be to (1) accept the funds from the Commonwealth and (2) distribute the funds to Virginia Union University upon receipt of written notification to release funds from the State Council of Higher Education for Virginia.

The funding will support the initiative to provide funding support to agencies and institutions within Virginia's Historically Black Colleges and Universities (HBCU) for creation and support towards a newly design Innovation Center.

**FISCAL IMPACT/COST:** No direct impact/ cost as the result will be a net neutral from a city fiscal perspective. The City will receive \$2,000,000 from the Commonwealth and then distribute such funds to the recipient when the State Council of Higher Education for Virginia directs the City to release funds.

FISCAL IMPLICATIONS: The result will be a net neutral from a city fiscal perspective.

**BUDGET AMENDMENT NECESSARY:** Yes, this O&R request an ordinance to amend the FY2022-2023 special fund budget in order to appropriate the funds received from the Common-wealth. Appropriating the funds into a special fund created solely for this purpose will facilitate both (1) the funds to be accepted/appropriated and (2) the funds being disbursed by the City.

**REVENUE TO CITY:** The City will receive \$2,000,000 in new revenue and those funds will be disbursed to the recipient so the result will be net neutral.

The 2022 General Assembly approved a one-time appropriation to support an initiative in the City of Richmond. Chapter 2 of the 2022 Special Session I, Virginia Acts of Assembly, including the following language in Item 144.

V. Out of this appropriation, \$2,000,000 the first year from the general fund is designated for the creation and support of an Innovation Center at a Historically Black College or University in the City of Richmond. The Director, State Council of Higher Education for Virginia, shall transfer this funding to the City of Richmond for costs associated with the Innovation Center.

Accordingly, the purpose of this memorandum is to authorize the transfer of \$2 million from the budget of the State Council of Higher Education for Virginia to the City of Richmond, upon agreement and acknowledgement of the terms and conditions by Virginia Union University, which is a Historically Black College or University in the City of Richmond.

The funding is contingent on Virginia Union University using the money in the approximate categories of spending outlined in the attached budget summary. A deviation in any category by more than 20 percent must be reported to the Director, State Council of Higher Education, at least 10 days prior to the expenditure. Any funding remaining unused by June 30, 2026, shall be returned to the Commonwealth.

No later than June 30, 2024, and each year thereafter through June 30, 2026, Virginia Union University will prepare and deliver a report to the Director, State Council of Higher Education for Virginia, on the expenditure of funds to date and on the following four outcomes:

- 1. The number of new graduates ready for professional careers in cybersecurity
- 2. The number and a description (company, wages, academic credit, etc.) of student internships in the fields of Science, Technology, Engineering and Math (STEM)
- 3. Description of outcomes related to preparing a diverse and prepared workforce to address skills shortages

## 4. Specific laboratory instrumentation and equipment and its use in accelerating economic growth

Upon a written agreement of these terms and conditions by Virginia Union University, and acknowledgement by the City of Richmond, through the office of the Mayor (see signature lines below), the State Council of Higher Education will transfer \$2 million to the City of Richmond.
