THE CITY OF RICHMOND HEREBY ORDAINS:


§ 1. That two additional stop signs shall be installed at the intersection of Nottoway Avenue and Fauquier Avenue for the purpose of making the intersection an all-way stop by no later than 180 days after the date of the adoption of this ordinance.

§ 2. This ordinance shall be in force and effect upon adoption or such other date as may be fixed by traffic order of the Director of Public Works if, prior to adoption, the two additional stop signs have been installed at the intersection of Nottoway Avenue and Fauquier Avenue.

ORDINANCE/RESOLUTION SUMMARY

The patron requests that legislation be drafted for Council's consideration requiring the installation of stop signs at the intersection of Fauquier Avenue and Nottoway Avenue, no later than 6 months after Council's adoption of the legislation requiring installation of the signage.

BACKGROUND

Although DPW has determined that traffic in the impacted area does not warrant installation of stop signage, the area residents disagree. The Bellevue Civic Association has submitted a petition to the patron requesting that stop signs erected at the intersection Fauquier Ave and Nottoway Ave due to the danger that persistent speeding presents to children, pedestrians, and other vehicles.
