**PURPOSE:** To amend Ordinance 2023-071 adopted May 8, 2023, and to authorize the Chief Administrative Officer to accept and appropriate \$15,000 from the National League of Cities for Fiscal Year 2023-2024 Special Fund Budget for the purpose of providing Technical Assistance for the City and to appropriate the funds into the Special Fund called the National League of Cities.

**REASON:** The National League of Cities awarded the City of Richmond Office of Minority Business Development (OMBD) a grant to be expended on training and technical assistance pro-vided by the City Inclusive Entrepreneurship (CIE) Grant Program in collaboration with Collab Capital.

**RECOMMENDATION:** The City Administration recommends adoption of this Ordinance.

BACKGROUND: The Office of Minority Business Development (OMBD) is coordinating cohorts of city organizations to participate in a 12-month Technical Assistance Program (i.e., National League of Cities). These cohorts are: Office of Minority Business Development (OMBD)/Ownership & Optionality- helping innovative Black-owned firms raise venture capital and connect to mentorship networks; Metropolitan Business League (MBL)/Entrepreneurship Curriculum - Establishing a local affiliate for entrepreneurship curriculum to equip aspiring entrepreneurs with the skills they need; and Small Business Development Center (SBDC)/Ecosystem Accelerator - establishing and/or enhancing a network of entrepreneurial resource partners to accelerate small business goal attainment.

FISCAL IMPACT/COST: The City will use the \$15,000 in grant funds to pay for technical assistance and

consulting services

- Output: By April 2023, the ESO will apply to the Kauffman FastTrac Affiliate program.
- Outcome: By August 2023, at least ten entrepreneurs will have participated in a FastTrac program through their local affiliate, as measured by course enrollment and/or completion certificates from the affiliate.

### Ecosystem Accelerator:

- Outcome: By August 2023, the resource partner network will have accelerated its entrepreneurial and small business ecosystem by, 1) identifying gaps in its local/regional service provision, and 2) clarifying a proposed ecosystem enhancement plan accounting for AT LEAST ONE entrepreneurial or small business support pathway.

#### Ownership & Optionality:

- Keep NLCI staff apprised of commitment implementation progress, including unexpected setbacks or staffing changes, throughout the grant performance period.
- If necessary, be available to conduct a formal post-grant interview.

- Ensure that the programmatic lead for the city or at least one staff person from the city attends every quarterly group conference call.
- Spend all funds or return to NLCI any remaining unused funds by the end of the grant performance period.
- If funds remain at the conclusion of the performance period, Grantee will contact NLCl staff to discuss the possibility of a "No Cost Extension" (NCE), returning grant funds, and/or other options.
