PURPOSE: To accept the relinquishment and effect a termination of franchised air rights over the City of Richmond's right-of-way of East Canal St and Virginia St as granted to the property located at 106 Shockoe Slip (known as "Shockoe Plaza").

REASON: Relinquishment and termination of air rights request letter dated March 13, 2023, from Hirschler Fleischer as representatives of Highwoods Realty Limited Partnership.

RECOMMENDATION: The Department of Public Works offers no objections to the relinquishment and termination of these air rights.

BACKGROUND:

Highwoods Realty LP (applicant) is the owner of certain real estate and improvements thereon variously and commonly known as 106 Shockoe Slip, 100 Virginia Street, 1310 East Cary Street, 1315 East Cary Street, 104 Virginia Street, 1313 East Cary Street, and 1321 East Cary Street, and

identified as City Parcel Nos. E0000066024, E0000066032 and E0000066033 (the "Property"). The improvements on the Property were constructed in 1996 with aerial projections encroaching less than two (2) feet into the rights of way of each of East Canal Street and Virginia Street (the "Encroachments"). The Encroachments are permitted pursuant to City Ord. No. 83-293-84-6, adopted January 9, 1984, as amended and re-ordained in City Ord. No. 85-219-209, adopted August 26, 1985, as evidenced by that certain Deed of License dated August 28, 1986, and recorded in the Office of the Clerk of the Circuit Court for the City of Richmond, Virginia (the "Clerk's Office") in Deed Book 118 at page 1491 (the "Encroachment Permit").

In connection with now-abandoned plans to expand the improvements located upon the Property over and across the right of way of East Canal Street and further into the right of way of Virginia Street, the City granted to applicant's predecessors in title certain franchised air rights as follows: (i) to C&M Properties, Inc., franchised air rights over the right of way of East Canal Street pursuant to City Ord. No. 84-153-135, adopted June 25, 1984, as evidenced by that certain Franchise dated June 25, 1984, and recorded in the Clerk's Office in Deed Book 242 at page 0995 (the "First Franchise"); and (ii) to Shockoe Plaza Associates, LP, franchised air rights over the rights of way of each of East Canal Street and Virginia Street pursuant to City Ord. No. 90-385-344, adopted December 10, 1990, as evidenced by that certain Franchise Agreement dated December 10, 1990, and recorded in the Clerk's Office in Deed Book 255 at page 910 (the "Second Franchise", and together with the First Franchise, the "Franchises").

The applicant has determined that the Franchised air rights are no longer required for its use of the Property, since its only current encroachments into the air space above the rights of way of East Canal and Virginia Streets are the Encroachments, which are permitted pursuant to the Encroachment Permit, and it has no plans to construct further encroachments into the adjoining rights of way. In order to avoid any future clouds on its title to the Property, it has been requested that the City accept a relinquishment and termination of the franchised air rights.
