I am writing to request that the above referenced issue not be voted on at your February 12<sup>th</sup> City Council meeting, but that consideration be postponed until another City Council meeting. Gather would very much like to provide input regarding this decision, but we have not had the opportunity to do so. A sign was posted in front of the building indicating that a zoning issue was being considered. We saw it on January 19<sup>th</sup>. There was a number listed on the sign to call for information. Gather owners and employees called that number at least eight times during normal business hours. The phone was never answered. The recording we heard said to leave a message and the department would get back to us as quickly as they could. We did not receive a callback until Tuesday, February 6<sup>th</sup> at 3:47pm.

Jimmy Dealaman in the City of Richmond Department of Planning and Development Review returned our call. At that time, we learned that our neighbor, Ember had filed for a special use

permit to allow them to operate a nightclub between midnight and 2:00am. By the way, we had asked Ember if they new what the sign was. They told us that they had no idea. After explaining that Ember had requested a special use permit, Jimmy told us that the Department of Planning and Development was going to consider the request at a meeting at 6:00pm that evening. Less than three hours from the time we received the only callback to our repeated calls. Gather took every reasonable effort to find out what was going on.

Unfortunately, my husband and I were in an airline lounge at Dulles Airport preparing to get on a plane to fly to Europe at 5:50pm that same evening. Obviously, there was no way we could be at that meeting. Further, we will not be back from Europe until Wednesday, February 14<sup>th</sup>, so we will not be able to attend the meeting on Monday, February 12<sup>th</sup> either. Ember has caused Gather significant monetary losses. We have had members leave because of the noise they generate. We have had prospective members tell us that they would love to join Gather, but couldn't because of the noise from Ember. We have had property damage because the noise is so loud and the vibrations so severe. For example, we have repeatedly had items vibrate off of member's desks, pictures fall off of member's walls, a water cooler vibrated its way down a hall and broke lose from its waterline resulting in a flood. Candidly, the vibrations are so severe that we are concerned they may damage the 100+ year old buildings.

Since opening, Ember has been operating an extremely loud nightclub until well into the early hours of the morning (i.e., beyond 12:00 midnight) in spite of the fact that the code apparently says that they had to stop at midnight. Further, Gather installed a device inside of its location to record noise levels. At times when the maximum allowed noise level according to city code is 75 decibels, we routinely record 95+ decibels. The scale that measures decibel levels is logarithmic, not linear. This means that 95 decibels is not 27% louder than the 75 decibels allowed by the City of Richmond ordinance, it is actually approximately four times the maximum allowed level.

Given that Ember has been knowingly violating city ordinances since opening and that we have not had an opportunity to comment on the special use permit, we respectfully request that City Council not consider this issue until we can be there to comment. If this is not possible, we respectfully request that the special use permit contain wording that says the occupant of 309 East Main Street may not violate the noise ordinance of the City of Richmond at any time and if it does the special use permit will be rescinded and the occupant will be required to cease operating its nightclub at midnight.

I would like to respond to Polly's email. I'm also a part-owner of Gather, and I am the Managing Member for the entity that owns the property. I do not share Polly's views or concerns.

I think Ember is a great addition to the Arts District, and it brings people/life/vitality/entertainment to that neighborhood. There are no residential units above or beside Ember, so noise is not a concern. This is a stretch of Broad Street that was blighted for decades. Someone was shot and killed in this building a decade ago (jewelry store robbery). They sold drugs across the street for decades as well. I am in full support of Ember getting this license and I'm ok having them open

later. This, in fact, helps Gather, not hurts it. If Ember is open later, they can start shows later, so the noise doesn't bother office workers at Gather. No one is at Gather (or any office) from midnight to 2am.


